

Delegate Information and Visa Requirements for CCAMLR-XXIII

Members' attention is drawn to the revised requirements for submitting information on delegates attending CCAMLR meetings, including working group meetings, in Hobart.

As requested in COMM CIRC 04/28 and COMM CIRC 04/63, a personal information form must be submitted for each nominated representative attending CCAMLR meetings. The CCAMLR Secretariat has now received a number of such forms.

Members are reminded that the personal information form does not replace the requirement for each Commission Member contact to provide the Secretariat with an official list of their delegates. Members are also advised that delegates cannot be regarded as officially nominated representatives until such a list has been received.

Further, the submission of the personal information form to CCAMLR does not replace application for an Australian visa. Any delegate without a current Australian visa should submit an application to the relevant Australian embassy without delay. The information contained in the personal information forms will be forwarded by the Secretariat to the Department of Immigration, Multicultural and Indigenous Affairs for onward transmission to the relevant overseas visa offices as additional information to expedite the issuing of visas.
