**Conservation Measures and Resolutions adopted  
at the Twenty-eighth Meeting of CCAMLR**

Members are hereby officially notified of the following revisions to the CCAMLR conservation measures which were adopted by the Commission at the Twenty-eighth Annual Meeting. The date for notification for the purposes of Article IX.6 of the Convention is 11 November 2009.

Conservation Measures 32-09 (2008), 33-02 (2008), 33-03 (2008), 41-01 (2008), 41-02 (2008), 41-03 (2008), 41-04 (2008), 41-05 (2008), 41-06 (2008), 41-07 (2008), 41-08 (2008), 41-09 (2008), 41-10 (2008), 41-11 (2008), 42-02 (2008), 51-04 (2008), 51-05 (2008), 52-01 (2008), 52-02 (2008), 52-03 (2008) and 61-01 (2008) will lapse on 30 November 2009. Conservation Measure 42-01 (2008) will lapse on 14 November 2009. These conservation measures dealt with fishery-related matters for the 2008/09 season.

Conservation Measure 91-02 (Protection of the Cape Shirreff CEMP site) was rescinded with the protection of Cape Shirreff continuing under the management plan of ASPA 149.

Resolutions 21/XXII and 26/XXVI were also rescinded.
