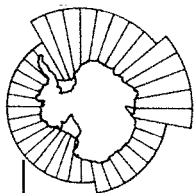

## **Notification of Australia's intention to conduct pot fishing trials in Division 58.5.2 for *Dissostichus eleginoides***

### **Delegation of Australia**

#### **Background**

At CCAMLR XXI “the Commission noted that Australia had notified the commencement of a longline fishery for *D. eleginoides* in Division 58.5.2. That notification was not formally for a new or exploratory fishery, but rather for the introduction of a new fishing gear to an established fishery. The Commission welcomed the approach taken by Australia in providing advance notification of the proposed fishery and of the management provisions planned for that fishery” (CCAMLR XXI, para 9.4).

#### **Proposal**

Consistent with Australia's approach at CCAMLR XXI Australia notifies its intention to conduct pot fishing trials in Australia's Exclusive Economic Zone (EEZ) within Division 58.5.2 for *D. eleginoides* in the coming seasons. This Division is unique within CCAMLR waters in that there is an established fishery for *D. eleginoides* harvested by trawling and longlining. These pot fishing trials will be undertaken in accordance with all relevant conservation measures including Conservation Measure 24-01 (2002), *The Application of Conservation Measures to Scientific Research*.

These trials are not intended to take more than the 10 tonne threshold for *Dissostichus* spp. and as such there is no requirement to submit a research plan as outlined in CM 24-01 (2002) paragraph 3(a).
