gears of the fishing vessel «MARIGOLDS»

The State Agency of Fisheries of Ukraine would like to express assurances of its highest respect to the Commission for the Conservation of Antarctic Marine Living Resources and has the honor to inform you about the following.

The operator of the fishing vessel «MARIGOLDS» flying the flag of Ukraine harvesting toothfish in the CCAMLR Convention Area informed the State Agency of Fisheries of Ukraine about a delay in the removal of the long-line number 73 at coordinates LAT 67.58,3 S; LON 122.06,9 W due to difficult weather conditions after the closure of the CCAMLR Subarea 88.2 H.

As soon as this notification from the CCAMLR Secretariat about the planned closure of fishing activity in Subarea 88.2 H on February 04, 2021, at 08:00 (UTC) was received, the fishing vessel «MARIGOLDS» did not place any new fishing gears and sent a notice to the CCAMLR Secretariat about the possible delay.

The vessel completed lifting the long-line number 73 on February 4, 2021, at 12:07 (UTC) and went beyond Subarea 88.2 H.

Taking this into account, please note the above information and bring it to the attention of the Member States of the CCAMLR.

On a delay related to a lifting of fishing
gears of the fishing vessel «CALIPSO»

The State Agency of Fisheries of Ukraine would like to express assurances of its highest respect to the Commission for the Conservation of Antarctic Marine Living Resources and has the honor to inform you about the following.

The owner of the fishing vessel «CALIPSO» flying the flag of Ukraine harvesting toothfish in the CCAMLR Convention Area informed the State Agency of Fisheries of Ukraine about a delay in the removal of fishing gears due to difficult weather conditions after the closure of the CCAMLR Subarea 88.2 H.

The vessel placed the long-line number 76 with 15180 hooks on February 2, 2021, from 15:40 till 17:33 (UTC), between coordinates -69°50.29'S, -129°41.08'W and 69°57.30'S, -129°16.81'W.

As soon as this notification from the CCAMLR Secretariat about the planned closure of fishing activity in Subarea 88.2 H was received, the fishing vessel «CALIPSO» did not place any new fishing gears and sent a notice to the CCAMLR Secretariat about the possible delay.

The vessel completed lifting the long-line number 76 on February 4, 2021, at 09:59 (UTC) and went beyond Subarea 88.2 H.

Taking this into account, please note the above information and bring it to the attention of the Member States of the CCAMLR.
