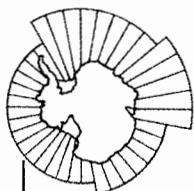

### Twenty-fourth Meetings of CCAMLR

In accordance with the Rules of Procedure, Members are invited to attend the Twenty-fourth Meetings of the Commission for the Conservation of Antarctic Marine Living Resources and the Scientific Committee which will be held in Hobart, Australia, from 24 October to 4 November 2005.

The venue for these meetings is at the new CCAMLR Headquarters which is located at 181 Macquarie Street, Hobart.

A preparatory meeting, for Heads of Delegation only, will be held on Sunday 23 October at 1600 h. This will be followed by a meeting for Scientific Committee Representatives only.

Members are reminded of their obligation to notify the Secretariat in advance of the meeting, the names of their representatives, alternate representatives and advisers. Members' attention is drawn to the requirement that, to facilitate visa processing, official Commission contacts should provide the Secretariat with a Personal Information Form for each person nominated to attend the meeting. This form is to be submitted at least two months prior to the person's intended date of departure. The form and revised instructions concerning visa requirements for entry into Australia were provided to Members in COMM CIRC 05/20-SC CIRC 05/07. This information is also available on the Commission and Scientific Committee 'Members Only' pages of the CCAMLR website.

Attached is an Information Note which includes details on the meeting venue, registration, travel arrangements and accommodation.

### Agendas

The attached Preliminary Agendas for the Commission and the Scientific Committee have been prepared in accordance with Rule 15 of the Commission's Rules of Procedure and Rule 5 of the Scientific Committee's Rules of Procedure respectively.

Also attached are the Preliminary Annotated Agendas.

Under Rule 16 of the Commission's Rules of Procedure and Rule 6 of the Scientific Committee's Rules of Procedure, proposals for the inclusion of supplementary items for the Provisional Agenda with accompanying explanatory memoranda, are to reach the Secretariat not later than 65 days before the meeting, this is by 20 August 2005.

### **Observers**

In accordance with the Commission's decision at last year's meeting, invitations to attend CCAMLR-XXIV as Observers have been extended to the Acceding States, non-Contracting Parties and international organisations listed in paragraphs 18.1 and 18.2 of CCAMLR-XXIII. Invitations have also been extended to the South East Atlantic Fisheries Organisation (COMM CIRC 05/40) and the Cook Islands, the Republic of Georgia, Guinea and the Sultanate of Oman, non-Contracting Parties believed to be involved in the harvesting or trade of *Dissostichus* spp.

### **Submission of Papers**

Attached are the guidelines for submission of papers to both the Commission and Scientific Committee. Members' attention is drawn to the deadlines set out therein.

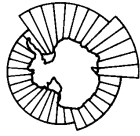
### **Meeting Schedule**

## CCAMLR-XXIV INFORMATION NOTE

The following information is provided by the Secretariat for the use of Member and Observer delegations to the Twenty-fourth Meetings of the Commission and the Scientific Committee for the Conservation of Antarctic Marine Living Resources.

### 1. DATES

The meetings of both the Commission and Scientific Committee will be convened during the period from 24 October to 4 November 2005.

There will be a meeting for Heads of Member Delegations only at 1600 h on Sunday 23 October, to be followed by a meeting for Scientific Committee Representatives only.

### 2. VENUE:

CCAMLR Headquarters, 181 Macquarie Street, Hobart, Tasmania, Australia (see attached map).

#### Car parking:

Please note that parking on the Headquarters site is limited. Delegates are requested to park their vehicles offsite. The Market Place Car Park (3–4 Market Place) is open 24 hours, and the Village Cinema Car Park (179–181 Collins Street) is open from 0645 h to 2400 h. There are other parking stations nearby with shorter opening hours. The Secretariat will provide further details if required.

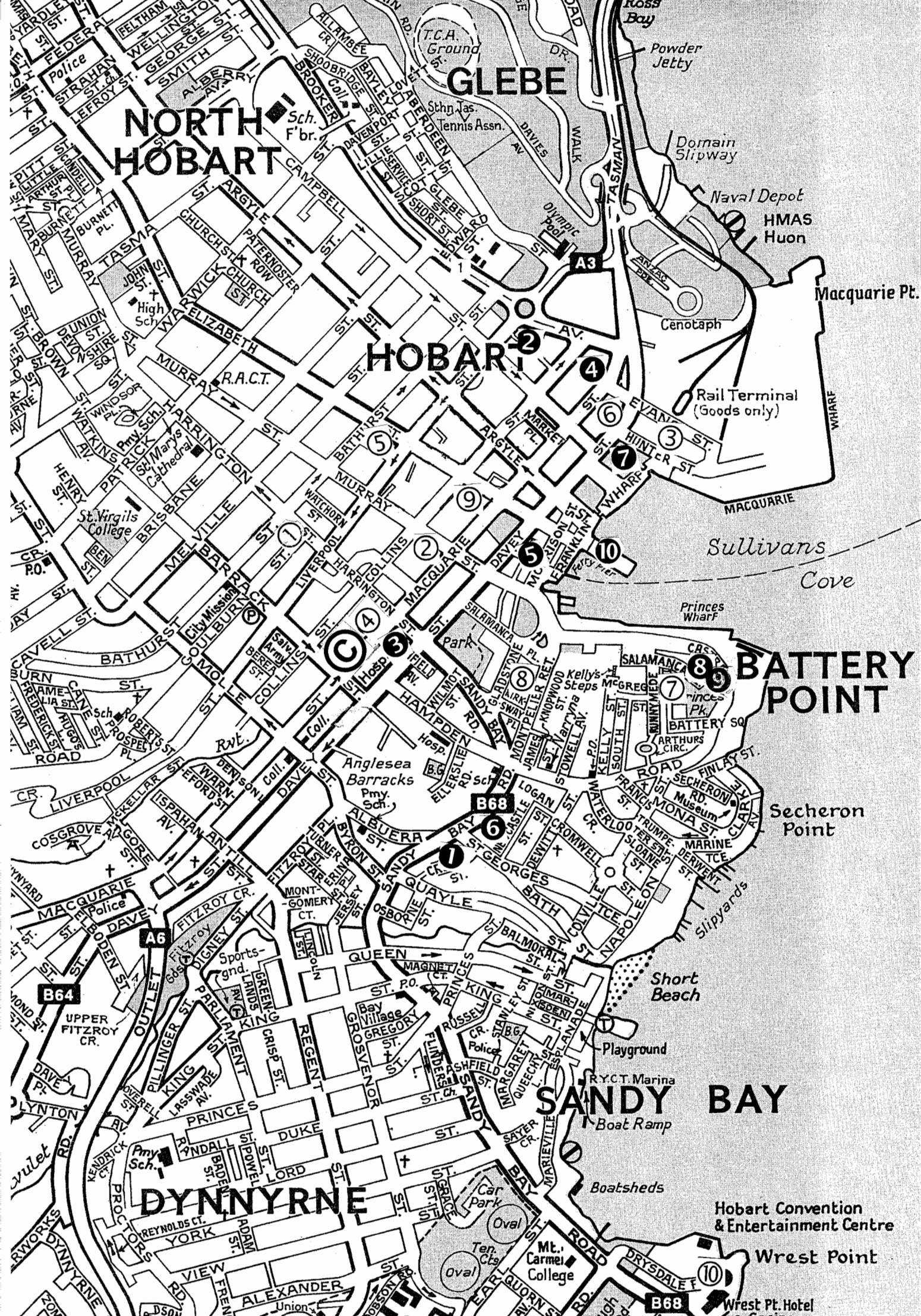

The Commission Chair ([name to be advised], Republic of Korea) will welcome delegates from CCAMLR Members as well as observers from CCAMLR Acceding States. The Chair will also welcome observers from non-Contracting Parties and international organisations invited in accordance with the decision taken last year (CCAMLR-XXIII, paragraphs 18.1 and 18.2).

The Chair will introduce His Excellency the Honourable William Cox, Governor of Tasmania, who will address the meeting.

**2. Organisation of the meeting**

Directly following the opening of the meeting, the Chair will deal with procedural matters only before adjourning the Commission to allow the Scientific Committee, SCAF and SCIC to carry out their work.

**(i) Adoption of the agenda**

**(vi) Special funds**

The Commission will receive the advice of SCAF, SCIC and the CDS Fund Review Panel on the use of the CDS Fund and other special funds during the 2004/05 intersessional period, and on any proposals received for use of the funds over the forthcoming intersessional period.

**(vii) Budgets for 2005, 2006 and 2007**

Based on advice from SCAF, the Commission will consider proposed changes to the adopted budget for 2005, adopt the budget for 2006 and note a forecast budget for 2007.

**(viii) Members' contributions**

The Commission will receive advice from SCAF on the application of Financial Regulation 5.6 on the timing of Members' contribution payments.

On the basis of advice from SCAF, the Commission will decide on a formula to be used for calculating Members' contributions to the budget for 2006, noting that last year the Commission endorsed a SCAF recommendation that the formula used for calculating Members' contributions in 2004 should be used in 2005, and that this should be used for subsequent years until a Member requests that it be reviewed (CCAMLR-XXIII, paragraph 3.25).

**(ix) Reports of Members' Activities**

The Commission will consider a report from SCAF and the Scientific Committee on which aspects of Members' annual reports of their activities in the Convention Area should be made publicly available (CCAMLR-XXIII, paragraph 3.8).

**4. Scientific Committee**

The Chair of the Scientific Committee will introduce the report of the Twenty-fourth Meeting of the Scientific Committee containing advice and recommendations to the

Commission in accordance with the Convention's objectives. The Commission will consider the general recommendations, advice, research and data requirements of the Scientific Committee.

The Commission will also consider substantive matters related to ecosystem monitoring and management, harvested species, scientific research exemption, Secretariat supported activities, publications and the Scientific Committee's activities planned for 2005/06. This will include advice and recommendations on:

- the operation of the Vanuatu-flagged vessel *Atlantic Navigator* in the krill fishery in Area 48 (CCAMLR-XXIII, paragraphs 4.22 to 4.26);
- Members' intentions to fish for krill in the 2005/06 season (CCAMLR-XXIII, paragraph 4.29);
- outcomes from the 2005 Workshop on Management Procedures to evaluate options for subdividing the krill catch limit among SSMUs (CCAMLR-XXIII, paragraph 4.10);
- developments in the assessment of toothfish in Subarea 48.3 (CCAMLR-XXIII, paragraph 10.49);
- future activities of the Scientific Committee and the consolidation of the work for its working groups (CCAMLR-XXIII, paragraphs 4.10 and 4.61 to 4.63).

Other substantive matters arising from the Scientific Committee will be discussed under other parts of the Commission's agenda: assessment and avoidance of incidental mortality (item 5); IUU fishing (item 8); Scheme of International Scientific Observation (item 9); new and exploratory fisheries (item 10); fisheries management and conservation under conditions of uncertainty (item 12); marine protected areas (item 11); cooperation with other international organisations (item 15); and participation in the International Polar Year (item 19(i)).

## **5. Assessment and avoidance of incidental mortality**

The Commission's discussions will be conducted under the following subitems and will take account of the Scientific Committee's advice and recommendations.

**(i) Marine debris**

The Commission will consider the advice of the Scientific Committee on the biological impact of marine debris, and on the evaluation of scientific data from Members' surveys of beached marine debris and from observations of the incidence and impact of marine debris on marine living resources in the Convention Area.

The Commission will also consider SCIC's advice on the implementation of Conservation Measure 25-01 'Regulation of the Use and Disposal of Plastic Packaging Bands on Fishing Vessels'.

**(ii) Incidental mortality of seabirds and marine mammals during fishing operations**

The Scientific Committee's report will contain advice on the incidental mortality of seabirds and marine mammals during fishing operations.

In particular, the Scientific Committee will report on recent seabird and marine mammal research, developments in by-catch mitigation methods, education initiatives and other subjects of importance to the elimination of incidental mortality of seabirds and marine mammals in CCAMLR fisheries. Compliance with Conservation Measures 25-02 'Minimisation of the incidental mortality of seabirds in the course of longline fishing or longline fishing research in the Convention Area' and 25-03 'Minimisation of the incidental mortality of seabirds and marine mammals in the course of trawl fishing in the Convention Area' will be reviewed.

**6. Implementation and compliance**

**(i) Report of SCIC**

The Annotated Agenda of the SCIC meeting is given in Appendix B. The Chair of SCIC will introduce the report of the Committee's meeting, and detailed findings and recommendations will be considered by the Commission under subitems (ii) and (iii) below, as well as under other relevant agenda items.

**(ii) Compliance with conservation measures**

The Commission will review SCIC's advice on the implementation of compliance-related provisions of conservation measures in force, including licensing of vessels, data reporting, the System of Inspection, port inspections of Contracting and non-Contracting Party vessels and operation of the C-VMS.

**(iii) Compliance evaluation procedure**

The Commission will receive advice from SCIC on the intersessional work to develop a compliance evaluation procedure (CCAMLR-XXIII, paragraph 6.11; CCAMLR-XXIII, Annex 5, paragraph 3.30).

The Commission will consider the organisation of future work required to further develop a procedure for determining compliance with conservation measures in force.

**7. Catch Documentation Scheme for *Dissostichus* spp. (CDS)**

**(i) Report of SCIC**

The relevant advice from SCIC on the operation and performance of the CDS will be presented and the subitems below will be addressed.

**(ii) CDS annual report**

The operation of the CDS in 2004/05 will be reviewed. The Commission will consider the advice received from SCIC and decide whether any aspect of the CDS requires revision in order to improve its efficiency.

**(iii) Review of the E-CDS trial**

The Commission will review the results of the E-CDS trial and consider further steps required to implement a full-scale E-CDS.

## **8. Illegal, unregulated and unreported (IUU) fishing in the Convention Area**

### **(i) Report of SCIC**

The relevant advice from SCIC in relation to IUU fishing will be presented and the subitems below will be addressed.

### **(ii) Current level of IUU fishing**

The Commission will consider the current levels of IUU fishing in the Convention Area as reported by the Secretariat and considered by WG-FSA, the Scientific Committee and SCIC. The estimation of IUU catches is based on the current agreed methodology (CCAMLR-XXII, paragraph 6.12(viii)). The Commission will also consider whether the current compliance-related conservation measures effectively meet CCAMLR's objectives on the elimination of IUU fishing in the Convention Area.

The Commission will also consider and review progress in developing an improved methodology for estimating the total removals of toothfish, including estimation of IUU catches (CCAMLR-XXII, paragraph 6.12).

### **(iii) Review of current measures aimed at eliminating IUU fishing**

The Commission will consider the advice of SCIC on the implementation of Conservation Measures 10-06 'Scheme to promote compliance by Contracting Party vessels with CCAMLR conservation measures' and 10-07 'Scheme to promote compliance by non-Contracting Party vessels with CCAMLR conservation measures'. In particular, the Commission will consider SCIC's advice on the IUU Vessel Lists established in 2004 and the Proposed IUU Vessel Lists for 2005. The IUU Vessel Lists for 2005 will be adopted.

The Commission will consider the advice of SCIC and SCAF on the future operational requirements of Conservation Measure 10-04 'Automated satellite-linked Vessel Monitoring System (VMS)', in particular the advice on the proposed revision of the measure (COMM CIRC 04/95, 19 November 2004).

The Commission will also consider SCIC's advice on the revision of Conservation Measures 10-07 in order to make this measure consistent with the procedures of Conservation Measure 10-06 for establishment of the IUU vessel list for Contracting Party vessels (CCAMLR-XXIII, paragraph 10.15).

Progress on the preparation of an institutional plan of action on IUU fishing will be reviewed (CCAMLR-XXIII, paragraph 6.6).

## **9. Scheme of International Scientific Observation**

A summary of scientific observations undertaken in the 2004/05 season will be presented.

The Commission will receive advice from the Scientific Committee on the implementation of the scheme and consider actions recommended by SCIC and the Scientific Committee to ensure that the scheme continues to meet its objectives and operates in the most efficient and effective way.

## **10. New and exploratory fisheries**

Last year the Commission approved exploratory fisheries for toothfish in Subareas 48.6, 88.1 and 88.2 and Divisions 58.4.1, 58.4.2, 58.4.3a and 58.4.3b in the 2004/05 season (CCAMLR-XXIII, paragraphs 9.4 to 9.14). There were no notifications for new fisheries in 2004/05. The Commission will review the operation of these fisheries and the management measures in force.

The Commission will consider notifications from Members for new and exploratory fisheries in the 2005/06 season, received in accordance with Conservation Measures 21-01 'Notification that Members are considering initiating a new fishery' and 21-02 'Exploratory fisheries' respectively.

The Commission will consider the Scientific Committee's advice and recommendations relating to new and exploratory fisheries, including:

- the review of Conservation Measure 24-02 'Longline weighting for seabird conservation' (CCAMLR-XXIII, paragraph 10.24);

- developments in by-catch mitigation measures (CCCAMLR-XXIII, paragraph 10.42);
- the distribution of catch limits in each SSRU in Subarea 88.1 (CCAMLR-XXIII, paragraph 10.70);
- ways of developing exploratory fisheries at a rate which will ensure the sustainability of the *Dissostichus* spp. stocks and the collection of data for long-term assessment (CCAMLR-XXIII, paragraph 10.73; CCAMLR-XXII, paragraph 10.63);

## **11. Conservation measures**

### **(i) Review of existing measures**

The Commission will review existing conservation measures in the light of the Scientific Committee's advice and experience gained by Members in implementing measures in the 2004/05 season.

The Commission will consider SCIC's advice on work undertaken on the development of methods for assessing compliance with conservation measures and plans for future work.

Where appropriate, the Secretariat will report on proposals for the revision of existing measures which were prepared intersessionally in consultation with Members.

### **(ii) Consideration of new measures and other conservation requirements**

Conservation measures not already addressed in the course of the Commission's deliberations under other agenda items or under subitem 11(i) will be discussed under this subitem. It will include, in particular, consolidation of environmental protection-related provisions of the fishery regulation measures within a single conservation measure (CCAMLR-XXIII, paragraphs 10.101 and 10.102).

The Commission will also consider advice from the Scientific Committee on the application of Marine Protected Areas (MPAs) in the context of Article IX(g) of the Convention. The advice will include results of the intersessional MPA workshop and proposals for future work.

**12. Fisheries management and conservation  
under conditions of uncertainty**

The Commission will consider advice provided by the Scientific Committee.

**13. Data access and security**

The Commission will keep under review the access and security of CCAMLR data.

**14. Cooperation with other elements of the Antarctic Treaty System**

**(i) Cooperation with Antarctic Treaty Consultative Parties**

CCAMLR was represented at the Twenty-eighth Antarctic Treaty Consultative Party Meeting (ATCM-XXVIII) (June 2005, Stockholm, Sweden). The Executive Secretary will report on the meeting.

The Chair of the Scientific Committee participated in the Eighth Meeting of the Committee on Environmental Protection (CEP-VIII), and will provide a report on the meeting.

Future cooperation and participation in the meetings of the ATCM and CEP in 2006 will be discussed.

**(ii) Cooperation with SCAR**

The report of the Scientific Committee will contain results of its deliberations on cooperation with SCAR.

In addition, the CCAMLR Observer to SCAR and the SCAR Observer to CCAMLR will be invited to report on recent SCAR initiatives of interest to CCAMLR.



Future cooperation and participation in the meetings of the SCAR and its relevant subsidiary bodies in 2006 will be discussed.

**(iii) Assessment of proposals for Antarctic Specially Protected Areas and Specially Managed Areas, which include marine areas**

The Commission will consider the advice of the Scientific Committee on the assessment of draft management plans proposed under the Environmental Protocol to the Antarctic Treaty, for protected areas with marine area components, and submitted to CCAMLR for approval.

**15. Cooperation with other international organisations**

**(i) Reports of observers from international organisations**

The following international organisations have been invited to attend CCAMLR-XXIV as observers: ACAP, ASOC, CCSBT, CEP, CITES, COLTO, CPPS, FAO, FFA, IATTC, ICCAT, IOC, IUCN, IWC, SCAR, SCOR, SEAFO, SPC and UNEP.

Their reports will have been tabled. Representatives of these and other organisations present at the meeting will be invited to present any key items from their reports.

**(ii) Reports from CCAMLR representatives at meetings of international organisations in 2004/05**

Reports from CCAMLR representatives at the 2004/05 meetings of various international organisations (CCAMLR-XXIII, paragraph 14.26) will be received.

**(iii) Cooperation with CITES**

The Commission will review developments in cooperation between CCAMLR and CITES on matters of mutual interest, subject to CCAMLR-XXII, paragraphs 14.18 and 14.19.

**(iv) Partnership in FIRMS**

Noting responses to COMM CIRC 05/10, the Commission will further consider a possible partnership in the Fishery Resources Monitoring System (FIRMS). The Secretariat will report on recent developments.

**(v) Participation in CCAMLR meetings**

At its 2004 meeting, the Commission addressed concerns over the financial difficulties encountered by some developing States invited to participate in Commission meetings (CCAMLR-XXIII, paragraphs 3.9 and 3.10). COMM CIRC 05/19 provided details on the fund set up by the United Nations concerning financial support for attendance at CCAMLR meetings by non-Member States which are party to the 1995 Fish Stocks Agreement. Responses to this circular indicated that a cautious approach should be taken to this issue and that the Commission might wish to give the matter further consideration. SCAF's advice on the matter will also be considered.

**(vi) Nomination of representatives to meetings  
of international organisations in 2005/06**

The Commission will nominate CCAMLR Observers to the 2005/06 meetings of international organisations with which CCAMLR shares a common interest. The Secretariat has compiled a timetable of future meetings of international organisations, to the extent that these are known.

**16. Implementation of the objectives of the Convention**

Since 1996 the Commission has agreed that specific reflection on the objectives of the Convention continues to be an important requisite of each annual meeting. The Commission will consider proposals submitted for discussion under this item.

**(i) CCAMLR Symposium**

Subject to discussion under Item 2, the Commission will consider how it may wish to proceed on dealing with issues raised by the CCAMLR Symposium organised by Australia and Chile in early April 2005 (CCAMLR-XXIII, paragraph 15.1).

## **17. Election of Vice-Chair of the Commission**

In accordance with Rule 8 of the Commission's Rules of Procedure, a Commission Vice-Chair must be elected to serve from the conclusion of the CCAMLR-XXIV until the conclusion of the Commission's 2007 meeting.

## **18. Next meeting**

### **(i) Invitation of observers**

Since 1994 the Commission has addressed the invitation of observers to its next meeting under this agenda item (CCAMLR-XIII, paragraph 13.7). Acceding States, non-Contracting Parties and international organisations to be invited to CCAMLR-XXV will be identified.

### **(ii) Date and location**

The Twenty-fifth Meeting of the Commission will be held at the CCAMLR Headquarters Building (181 Macquarie Street) in Hobart between 22 October and 3 November 2006.

## **19. Other business**

### **(i) International Polar Year in 2007/08**

The Commission will consider the Scientific Committee's report and advice on intersessional work in preparation for the 2008 synoptic survey of krill, pelagic fish and plankton biomass and biodiversity in the South Atlantic (Area 48) which will be conducted under the auspice of the International Polar Year in 2007/08 (CCAMLR-XXIII, paragraph 19.8).

### **(ii) Twenty-fifth Meeting of CCAMLR**

The Twenty-fifth CCAMLR Meeting will be held in 2006. The Commission may wish to consider how it will celebrate this important milestone.

**20. Report of the Twenty-fourth Meeting of the Commission**

The report of the Twenty-fourth Meeting will be considered and adopted.

**21. Close of the meeting**

The meeting is scheduled to close at 1600 h on Friday, 4 November 2005.

**PRELIMINARY ANNOTATED AGENDA FOR THE 2005 MEETING  
OF THE CCAMLR STANDING COMMITTEE ON  
ADMINISTRATION AND FINANCE (SCAF)**

**1. Organisation of the meeting**

The Committee will adopt its agenda and consider the optimum way to address it, given the time available and the requirements of SCIC. In an attempt to relieve the time pressure on SCIC, the Heads of Delegation meeting on Sunday 23 October 2005 may change SCAF's working schedule for this year.

**2. Examination of audited Financial Statements for 2004**

As required by the Commission, the Auditor performed a full audit on the 2004 Financial Statements (CCAMLR-XXIII, paragraphs 3.4 and 3.5). No breaches of the Financial Regulations were reported. The Financial Statements, together with the associated audit report, will be presented for acceptance by the Commission. In this regard, note should also be taken of COMM CIRCs 05/14, 05/24 and 05/27.

**3. Audit requirement for the 2005 Financial Statements**

Under the Financial Regulations, the Commission may authorise a full audit for the 2005 Financial Statements, or may decide that only a review audit will be required. As a full audit was carried out on both the 2003 and 2004 statements, the provisional budget for 2006 assumes that a review only audit will be required for the 2005 statements.

**4. Secretariat Strategic Plan**

The Secretariat Strategic Plan to support the work of the Commission and the Scientific Committee was presented to the Commission in 2002. The Commission determined that implementation of the plan would form the basis of the Executive Secretary's annual performance appraisal. The Executive Secretary will present any new developments in this regard.

## **5. Reports of Members' Activities**

In response to a request from the Commission in 2003 (CCAMLR-XXII, paragraph 3.7), the Secretariat submitted a paper for consideration at the 2004 meeting outlining options for enhancing the value of Members' annual activities reports. The Executive Secretary was directed to liaise with the Scientific Committee to formulate a proposal to address the contents of the reports and the requirements as to which aspects of the reports would be made publicly available (CCAMLR-XXIII, paragraph 3.8). A report on any outcomes will be provided.

## **6. Education package**

The Secretariat will report on the progress of this project.

## **7. Support for participation at meetings**

At its 2004 meeting, the Commission addressed concerns over the financial difficulties encountered by some developing States invited to participate in Commission meetings (CCAMLR-XXIII, paragraphs 3.9 and 3.10). COMM CIRC 05/19 provided details on the fund set up by the United Nations concerning financial support for attendance at CCAMLR meetings by non-Member States which are also party to the 1995 Fish Stocks Agreement. Responses to this circular indicated that a cautious approach should be taken to this issue and that the Commission might wish to give the matter further consideration.

## **8. Review of 2005 budget**

The expected results of the 2005 budget will be presented for review.

## **9. Cost recovery**

In 2003 the Commission adopted a scheme for the recovery of costs associated with Members' notifications for new and exploratory fisheries. As directed by the Commission last year (CCAMLR-XXIII, paragraph 3.13), the Secretariat will present a financial comparison of the non-refundable portion of the fees received in relation to the relevant costs incurred. The Committee may then review future procedures.

## **10. Contingency Fund**

As required by the agreed procedures (CCAMLR-XXI, Annex 4, paragraph 21), the Executive Secretary will report on expenditure from the Contingency Fund during the year, together with any other budgetary consequences.

## **11. Professional Staff salaries**

No proposals have been submitted in respect of providing experts to review the Professional Staff salary structure. The Committee will consider how it may wish to proceed on this matter.

## **12. Budget for 2006**

A draft budget for 2006 will be presented. This will be used to prepare a recommended budget for 2006, taking into account SCAF's discussions on financial and administrative issues, as well as advice from the Chairs of the Scientific Committee and SCIC.

### **(i) Relocation of CCAMLR Headquarters**

Relocation of the Commission's annual meetings to its new Headquarters (181 Macquarie Street, Hobart) requires reallocation of expenditure previously reported as 'meeting expenditure' to 'administration costs'. Approval will be sought to formalise this change along with any other relevant variations. The Executive Secretary will also report on developments since CCAMLR-XXIII.

### **(ii) Operation of the C-VMS**

The Secretariat will report on the operation of the C-VMS since its inception under Conservation Measure 10-04. The Committee will consider how future funding for the system's future operation should be managed, taking into account any advice which the Secretariat may provide.

### **(iii) Scientific Committee budget**

The Chair of the Scientific Committee will be invited to present the Scientific Committee's budget for 2006 and its forecast budget for 2007 so that these may

be included in the Commission's overall budgets. She will also be invited to advise SCAF of any other Scientific Committee decisions which would affect the Commission's budget.

**(iv) Advice from SCIC**

The Chair of SCIC will be invited to present the financial implications of SCIC'S recommendations to the Commission for the Committee's consideration.

**13. Multi-year funding of Scientific Committee tasks**

At its 2004 meeting, the Commission endorsed the establishment and use of a Special Science Fund to enable deferral of funding to future years for certain Scientific Committee tasks. The operation of this fund will be reviewed, as will any requests for deferral of funds by the Scientific Committee.

**14. Members' contributions**

**(i) Timing of Members' contributions**

When revising Financial Regulation 5.6 in 1999, the Commission modified the date by which annual contributions are required to be paid. This revision permits Members who advise their inability to meet the deadline set out in Regulation 5.6 to have an extended deadline of up to 90 days. The Commission has agreed that the Committee will continue to review this regulation and Members' compliance therewith. The Committee will also consider the need to retain the extended deadline for some Members in 2006. The Secretariat will present a paper outlining the potential financial impacts of late contribution payments.

**(ii) Implementation of the contribution formula**

The Commission has agreed to retain the formula for calculating Members' contributions to the annual budget, which has applied from 2002 to 2004, for 2005 and until such time as any Member requests a review (CCAMLR-XXIII, paragraph 3.25).



**15. Forecast budget for 2007**

The Committee will present a forecast budget for 2007 to the Commission for information purposes only.

**16. CDS Fund**

Any requests for expenditure from the CDS Fund are required to be submitted through the CDS Fund Review Panel. The Committee will receive the advice of the panel on expenditure from the fund since the 2004 meeting and proposals received for future expenditure from the fund.

**17. Any other business**

The Committee will discuss any other business which the Commission may wish to refer to it for consideration.

**(i) Antarctic Treaty Secretariat funds**

Funds held since 2003 by the Secretariat on behalf of the Antarctic Treaty Secretariat have now been transferred to the latter following an instruction from the Treaty Depositary, the USA. The account has therefore been closed.

**18. Election of Chair and Vice-Chair of SCAF for 2006 and 2007**

In 2003 the Committee appointed Germany as the Chair of SCAF, with South Africa serving as Vice-Chair until the end of the 2005 meeting. Both the positions of Chair and Vice-Chair of SCAF will therefore be up for election.

**19. Adoption of the report**

The Committee will adopt its report to the Commission.

**20. Close of the meeting.**

**PRELIMINARY ANNOTATED AGENDA FOR THE 2005 MEETING

**1. Opening of the meeting**

**(i) Adoption of agenda**

The agenda for the meeting will be considered and adopted.

**(ii) Organisation of the meeting**

The organisation of the meeting will be decided taking into account the time available and the proposed structure for the Committee's deliberations.

**(iii) Review of submitted papers, reports and other presentations**

The Secretariat will present a summary list of documents submitted to SCIC which will be subdivided by agenda item. The Committee will consider the list of papers and any additional presentations proposed by Members. The Committee will then prioritise discussion of papers taking into account the time available, the meeting workload and the agenda.

**2. IUU fishing in the Convention Area**

**(i) Current level of IUU fishing**

The Committee will consider the report on current levels of IUU fishing in the Convention Area as prepared by the Secretariat and considered by WG-FSA. The estimation of IUU catches is based on the methodology currently accepted by the Commission, the Scientific Committee and WG-FSA (CCAMLR-XXII, paragraph 6.12(viii)). The Committee will review the estimates provided and consider whether the current enforcement measures effectively meet their objectives on the elimination of IUU fishing in the Convention Area.

The Committee will consider whether additional information on IUU activities would justify revision of IUU catches estimated for 2003/04 (CCAMLR-XXIII, Annex 5, paragraph 2.3).

**(ii) Procedure for estimation of IUU catches**

The Secretariat will report on intersessional work undertaken on developing a methodology for estimating total removals, including estimation of IUU catches. The Committee will discuss the organisation of future work on the subject (CCAMLR-XXII, paragraphs 6.12(vi) and (vii)), in particular, a request from the Scientific Committee on whether estimates of the most recent IUU fishing could be considered and confirmed by SCIC in time for the annual meetings of WG-FSA (SC-CAMLR-XXIII, paragraphs 7.10 and 7.23).

**(iii) IUU Vessel Lists**

The Committee will review reports submitted by Contracting and non-Contracting Parties on measures they have taken to avoid any undermining the effectiveness of CCAMLR conservation measures resulting from activities of their vessels included in the IUU Vessel Lists adopted in 2004.

The Committee will also review comments and information received on vessels included in the Provisional List of IUU vessels for 2005 in accordance with Conservation Measures 10-06 and 10-07.

The Committee will prepare recommendations to the Commission on vessels which should be removed from the IUU Vessel Lists adopted in 2004 and on vessels to be retained in the Provisional List of IUU Vessels prepared for 2005

**3. Review of compliance and implementation-related measures and policies**

**(i) Compliance with conservation measures in force**

The Secretariat will present a summary of inspections undertaken, the results of these inspections and comments received from Flag States. Flag States will be invited to present additional information, if any, with respect to inspections undertaken.

The Committee will consider any proposals received on the improvement of the System of Inspection.

The Secretariat will then present a summary of reports received on actions taken by Members with respect to compliance-related provisions of the Convention, including licensing of vessels, port inspections of Contracting and non-Contracting Party vessels and operation of the C-VMS.

Members will be invited to present any additional information on the implementation of compliance-related conservation measures.

**(ii) Compliance evaluation procedure**

The Secretariat will report on intersessional work directed at the development of a compliance evaluation procedure. In particular, the Committee will consider the types of monitoring data and methods of collection that are currently used in the assessment of compliance with conservation measures. Comments on the issue will also be available from the Chair of the Scientific Committee (CCAMLR-XXIII, paragraph 6.11; CCAMLR-XXIII, Annex 5, paragraph 3.30).

In addition, the Committee was requested to consider electronic (video) monitoring as a potential additional tool for monitoring compliance with conservation measures (SC-CAMLR-XXIII, paragraph 2.15).

The Committee will also consider the organisation of future work required to develop a procedure for determining compliance with conservation measures in force.

**(iii) Proposals for new and revised measures**

The Committee will consider any proposals for the revision of current compliance-related conservation measures or the establishment of any additional measures. If an additional measure is required, the Committee will prepare a draft of the measure and submit it for further consideration by the Commission. In particular, the Committee will consider revision of

Conservation Measures 10-04 (COMM CIRC 04/95 of 19 November 2004) and 10-07 in order to make the latter consistent with the procedures of Conservation Measure 10-06 for establishment of the IUU vessel list for Contracting Party vessels (CCAMLR-XXIII, paragraph 10.15).

The Committee will also consider any intersessional work undertaken by Members on the preparation of the CCAMLR plan in support of the FAO IPOA-IUU (CCAMLR-XXIII, paragraph 6.6).

#### **4. Catch Documentation Scheme (CDS)**

The Committee will consider the results of the CDS operation in 2004/05. The Committee will also consider whether any aspect of the CDS requires revision in order to improve its efficiency.

The Committee will consider a report prepared by the Secretariat on the E-CDS trial. Based on the results of the E-CDS trial, the Committee will consider the operational, administrative and financial requirements of a full-scale E-CDS.

#### **5. Scheme of International Scientific Observation**

The Committee will consider advice from the Scientific Committee on the operational requirements of the scheme, in particular, for the 2005/06 season. This will include advice on the scientific objectives and priorities for international scientific observation on board krill fishing vessels (CCAMLR-XXIII, paragraph 4.8)

Also taking account of any Scientific Committee advice, the Committee will consider whether revision is required of any of the operational aspects of the scheme.

#### **6. Election of the Vice-Chair of the Committee**

A Vice-Chair will be elected to serve for two years from the end of this meeting to the end of the meeting in 2007.

#### **7. Other business**

The Committee will consider any additional requests received from the Commission during the meeting.

**8. Advice to the Commission**

The Secretariat will present a summary of advice to the Commission prepared during this meeting for appending to the SCIC report.

**9. Advice to SCAF**

Any aspect of the Committee's advice with financial implications will be forwarded directly to SCAF. It will include, in particular, requirements for the full-scale implementation of the E-CDS and operation of the C-VMS.

**10. Adoption of the Report**

The report of the meeting will be adopted.

**11. Close of the Meeting**

The 2005 meeting of SCIC will be closed.

## **2. CCAMLR Scheme of International Scientific Observation**

### **(i) Scientific observations conducted in the 2004/05 fishing season**

The results of scientific observations carried out in accordance with the scheme in the 2004/05 season have been discussed by WG-EMM and WG-FSA and reported to the Scientific Committee. A summary of all observation programs undertaken and data received will be provided by the Secretariat.

The operation of the Scheme of International Scientific Observation during the 2004/05 season will be considered.

In particular, the Scientific Committee will consider the revision of research priorities for different fisheries, target and by-catch species and the type of data to be collected to allow research priorities to be met (SC-CAMLR-XXIII, paragraph 2.11). It will prepare advice to the Commission on the scientific objectives and priorities for the deployment of CCAMLR international scientific observers on krill fishing vessels (CCAMLR-XXIII, paragraph 4.8)

The results of intersessional work on the major revision of the *Scientific Observer Manual* will be reviewed. In particular, the Scientific Committee will review and endorse the terms of reference for the review, costs and timetable (SC-CAMLR-XXIII, paragraphs 2.8 to 2.13)

The reports of WG-EMM and WG-FSA will contain recommendations to the Scientific Committee on all the abovementioned matters.

### **(ii) Advice to the Commission**

The Scientific Committee will prepare advice to the Commission on matters of relevance to the implementation of the scheme and its objectives.

Consideration will also be given to the general operational requirements of the scheme for the forthcoming season so as to assist the Chair in preparing advice to SCIC.

### **3. Ecosystem monitoring and management**

In particular, the Scientific Committee will consider a report on the intersessional work of the Steering Committee for the proposed workshop on marine protected areas (SC-CAMLR-XXIII, paragraphs 3.52 and 3.53).

#### **(iii) Advice to the Commission**

The Scientific Committee will advise on recent developments in relation to ecosystem monitoring and management. The Scientific Committee will advise on the appointment of a new Convener of WG-EMM.

#### **4. Harvested species**

##### **(i) Krill resources**

###### **(a) Status and trends**

Members will be invited to inform the Scientific Committee of recent developments and trends in krill fisheries in the Convention Area. Fishery data reported for the current season will be summarised by the Secretariat.

**(c) Advice to the Commission**

The Scientific Committee will provide management advice.

**(v) Squid resources**

**(a) Status and trends**

Members will be invited to inform the Scientific Committee of recent developments and trends in squid fisheries in the Convention Area. Fishery data reported for the current season, if any, will be summarised by the Secretariat. Notifications for the exploratory fishery in Subarea 48.3 in the 2005/06 season will be reviewed and the advice of WG-FSA considered.

**(b) Advice from WG-FSA**

The Convener of WG-FSA (Dr Hanchet) will present the results of WG-FSA's deliberations on squid resources.

**(c) Advice to the Commission**

The Scientific Committee will provide management advice.

**(vi) Fish and invertebrate by-catch**

**(a) Status and trends**

Members will be invited to inform the Scientific Committee of recent developments and trends in by-catch from fisheries in the Convention Area. By-catch data reported for the current season will be summarised by the Secretariat.

## **5. Incidental mortality**

### **(i) Incidental mortality of seabirds and marine mammals arising from fisheries**

The Co-Conveners of ad hoc WG-IMAF (Dr K. Rivera, USA and Mr N. Smith, New Zealand) will report on the intersessional activities of ad hoc WG-IMAF and the group's meeting conducted as part of WG-FSA.

The Scientific Committee will consider the recommendations of ad hoc WG-IMAF and WG-EMM on research priorities, developments in fishing methods, education and other subjects of importance to the elimination of incidental mortality of seabirds and marine mammals arising from fisheries.

### **(ii) Advice to the Commission**

The Scientific Committee will provide management advice.

## **6. Additional monitoring and management issues**

### **(i) Marine debris**

Members are required to report results of marine debris surveys and observations on the incidence and impact of marine debris on Antarctic marine living resources according to standard reporting requirements adopted at CCAMLR-XX (paragraphs 6.1 to 6.5). The Scientific Committee will consider the information contained in reports received, particularly on technical aspects of monitoring and analysis of marine debris data (SC-CAMLR-XXIII, paragraphs 6.4 to 6.6).

An annual report on the status and trends in marine debris-related observations will be submitted by the Secretariat.

### **(ii) Marine mammal and bird populations**

At its Sixth Meeting, the Scientific Committee decided to review the status of and trends in marine mammal and bird populations every three to five years (SC-CAMLR-VI, paragraph 8.7). The next review will be completed in 2006.



The Scientific Committee will consider the advice of WG-EMM and WG-FSA on the refinement of CCAMLR's request to SCAR for information on the status and trends of marine mammal and bird populations (SC-CAMLR-XXIII, paragraph 6.18).

**(iii) Advice to the Commission**

The Scientific Committee will provide management advice concerning marine debris and its impact on Antarctic marine living resources, and the review of marine mammal and bird populations.

**7. Management under conditions of uncertainty about stock size and sustainable yield**

Following earlier requests from the Commission, discussions on this topic are included as a permanent item on the Scientific Committee's agenda (CCAMLR-XIII, paragraph 10.4).

The Scientific Committee will consider the recommendations of WG-FSA and WG-EMM regarding Fishery Plans and the regulatory framework.

The Scientific Committee will take note of any intersessional work undertaken by SCIC and WG-FSA on the revision of IUU estimation methods. It will then review estimates of IUU catches and recent trends in IUU fishing activities as prepared by the Secretariat and considered by WG-FSA.

**8. Scientific research exemption**

The Scientific Committee will consider available information regarding the review of Conservation Measure 24-01, Annex 24-01/B.

The Scientific Committee will provide management advice, as appropriate.

## **9. Cooperation with other organisations**

### **(i) Cooperation with the Antarctic Treaty System**

The Chair will report on the Eighth Meeting of the Committee on Environmental Protection to the Antarctic Treaty (CEP).

The Scientific Committee will discuss cooperation with SCAR based on reports received from the SCAR Observer and the CCAMLR Liaison Officer to SCAR.

### **(ii) Reports of observers from other international organisations**

Reports will be received from representatives of international organisations present as observers at the Scientific Committee meeting. Those invited include: ACAP, ASOC, CCSBT, CEP, CPPS, FAO, FFA, IATTC, ICCAT, IOC, IUCN, IWC, SCAR, SCOR, SPC and UNEP.

### **(iii) Reports of representatives at meetings of other international organisations**

Reports will be received from representatives nominated by the Scientific Committee to attend meetings of other international organisations during 2004/05 (SC-CAMLR-XXIII, paragraph 9.40).

### **(iv) Future cooperation**

The Scientific Committee will discuss the further development of its cooperation with other international organisations and consider any proposals for cooperation received by the Scientific Committee under subitems (i) and (ii) above.

Observers will be nominated to participate in meetings of other international organisations in 2005/06. A calendar of known international meetings of interest to the Scientific Committee has been compiled by the Secretariat.

The Scientific Committee will consider the invitation of observers from international organisations to the next meeting of the Scientific Committee and to its working groups during the 2005/06 intersessional period.

## **10. Budget for 2006 and forecast budget for 2007**

The financial implications of decisions taken under Agenda Items 2 to 13 will be used to prepare a detailed Scientific Committee budget for 2006. This budget will be based on the costs of ongoing projects and new proposals considered during the Scientific Committee's meeting. A forecast budget for 2007 will also be discussed.

In developing its budget, the Scientific Committee will need to take account of the needs for invited experts, other contracted work and multi-year funding.

The Scientific Committee will need to identify requirements for invited experts at working group meetings, including their terms of reference, costing and expected outputs and reporting. The Scientific Committee will also need to establish the terms of reference for the proposed review of the *Scientific Observers Manual* and determine the costs involved.

Last year the Commission endorsed the establishment and use of a Special Science Fund to enable the deferral to future years of funding for specific tasks of the Scientific Committee (CCAMLR-XXIII, paragraph 3.22 and Annex 4, paragraph 26). The Commission agreed that A\$4 500, budgeted in 2004 for expenditure on reviewing the Generalised Yield Model (GYM), should be carried forward in the Special Science Fund for expenditure in future years (CCAMLR-XXIII, paragraph 3.23). The Commission also noted that the proposed review of the *Scientific Observers Manual* would have financial implications, some of which would require the introduction of a new multi-year arrangement (CCAMLR-XXIII, paragraph 4.6). The Scientific Committee will consider multi-year funding and advise to the Commission.

## **11. Advice to SCIC and SCAF**

The Scientific Committee will summarise for the Commission its recommendations to SCIC and SCAF on matters relating to their work. In particular, the Scientific Committee will comment on the types of monitoring data and methods of collection that are currently used in the assessment of compliance with conservation measures. A list of data types and monitoring methods will be submitted by the Secretariat (CCAMLR-XXIII, paragraph 6.11; CCAMLR-XXIII, Annex 5, paragraph 3.30).

## **12. Secretariat supported activities**

### **(i) Data management**

The Scientific Committee will review the data management requirements of the Secretariat. The Data Manager will report on the measures taken to maintain the integrity of the CCAMLR database (SC-CAMLR-XVI, paragraph 10.14).

### **(ii) Publications**

The 12th volume of *CCAMLR Science* will be published just prior to CCAMLR-XXIV. The Chair of the Editorial Board will advise of any changes, if required, to the editorial policy of *CCAMLR Science*. The Scientific Committee will advise the Commission on future CCAMLR publication requirements.

Other CCAMLR documents published in 2005 include:

## **13. Scientific Committee activities**

The intersessional activities of the Scientific Committee in 2005/06 will be discussed so as to ensure that the dates and venues for meetings of working groups are agreed, that the requirements for the timing of data submission to the Secretariat are understood, and that actions to be undertaken by the Chair, Conveners of working groups, Members and the Secretariat, and the timing of such actions, are clearly identified.

On the basis of advice from working group Conveners and in accordance with Rule 2 of the Rules of the Scientific Committee, the Scientific Committee will decide whether invitations should be extended to scientists and ‘experts’ to attend intersessional meetings of its working groups.

**(ii) Invitation of observers to the next meeting**

The Scientific Committee will consider the invitation of observers to its next annual meeting and the intersessional meetings of its working groups

**(iii) Invitation of experts to the meetings of working groups**

The Scientific Committee will consider advice from WG-EMM and WG-FSA, if required, for the participation of invited experts at forthcoming working group meetings.

**(iv) Next meeting**

The next meetings of the Scientific Committee and the Commission to be held at CCAMLR Headquarters in Hobart from 23 October to 3 November 2006.

**14. Election of Vice-Chair of the Scientific Committee**

## **SUBMISSION OF PAPERS TO MEETINGS OF THE COMMISSION\***

*These rules aim to ensure that papers are submitted in sufficient time and in an appropriate form for delegates to be able to read them and absorb their contents before matters contained therein are addressed. This will also enable the substance of each paper to be given due and equal consideration.*

All papers considered by the Commission to support the taking of decisions are denominated 'working papers'. Papers provided for background information only are 'background papers'.

2. Working papers require translation into the four official languages. The deadline for submission to the Secretariat is 45 days prior to the beginning of the meeting (Table 1), to allow for processing, including translation.

3. It is usual that the substance of any paper will be included in the main text. Therefore, to avoid undue cost and delay of translation, only the main body of text will be translated and not any appendices or attachments.

4. Background papers, including reports from observers to the meeting, should be submitted to the Secretariat no later than 30 days prior to the beginning of the meeting (Table 1). These are made available to delegates in the language of submission.

5. Papers should be submitted by email to [webmaster@ccamlr.org](mailto:webmaster@ccamlr.org) in Microsoft Word format.

6. Papers received by the Secretariat by the stated deadlines will be processed and made available to Members on the CCAMLR website in advance of the meeting.

7. Papers received after the stated deadlines but before 15 days prior to the beginning of the meeting will be processed and distributed to participants at registration in the language of submission, as well as being placed on the website. Translation of working papers will be possible only to the extent that the length of the paper and the date of submission permit.

8. Papers received later than 15 days after the stated deadlines but before the start of the meeting will be processed and distributed to participants, if possible, at registration, otherwise during the meeting, subject to the requirements of the meeting.

9. Papers submitted after the beginning of the meeting will not be accepted unless the Chair of the meeting considers that they are of sufficient importance and that delegates will have enough time to give them adequate consideration before the relevant agenda item is discussed. In the case of working papers, translation will depend on the prioritisation of all translation work during the meeting, as determined by the Executive Secretary.

10. Background documents prepared by Member delegates during the meeting in response to identified requirements must be submitted by, or on behalf of, the Head of Delegation and will be processed and distributed as quickly as possible.

11. Each working paper and background paper should include a title page and an abstract. The title page should contain:

- (i) reference to the meeting to which the paper is submitted (e.g. in 2004, CCAMLRL-XXIII);
- (ii) the specific agenda item number(s) to which the paper refers;
- (iii) the title of the paper;
- (iv) the name of the Member/organisation, and of the author(s) if applicable, submitting the paper to the meeting;
- (v) the following disclaimer:

‘This paper is presented for consideration by CCAMLRL and may contain unpublished data, analyses, and/or conclusions subject to change. Data in this paper shall not be cited or used for purposes other than the work of the CCAMLRL Commission, Scientific Committee or their subsidiary bodies without the permission of the originators and/or owners of the data.’

12. The main body of text should not exceed five A4 pages with a maximum of 10 pages of additional information.

- (ii) widely publicise the abovementioned activities of CCAMLR by placing these reports on a public access page of the CCAMLR website.*

Reports of Members' Activities should cover the intersessional period since the previous meeting of the Commission and comprise summary information\* on the following items:

### **1. Fishery-related activities:**

- (a) fisheries undertaken, in what areas and periods, as well as the total catch by species, and information of planned fishing activities for the year ahead;
- (b) participation in the Scheme of International Scientific Observation (the number of observers deployed, fisheries and areas covered).

### **2. Compliance and enforcement:**

- (a) advice on existing legal or administrative procedures used to annually give effect to the implementation of the CCAMLR conservation measures;
- (b) participation in the CCAMLR System of Inspection including the number of inspectors designated and vessels inspected;

- (c) significant diplomatic demarches made to further cooperation with non-Contracting Parties.

**3. Research activities in relation to marine living resources and the CCAMLR Ecosystem Monitoring Program:**

- (a) research surveys and study programs undertaken by major topics, species and study areas;
- (b) cooperation in research surveys and programs with other CCAMLR Members;
- (c) participation in the CCAMLR Scheme of International Scientific Observation, including the number of observers designated and deployed.

**4. Research activities on the assessment and avoidance of incidental mortality of Antarctic marine living resources:**

- (a) research on the assessment of levels of marine debris pollution in the Convention Area and its biological impact on Antarctic marine living resources;
- (b) research on the reduction and avoidance of incidental mortality of seabirds and marine mammals in fishing operations;
- (c) list of surveys of beached marine debris which have been carried out.

Contracting Parties are invited to submit for consideration at meetings of the Scientific Committee, working papers<sup>1</sup> and background papers related to specific items of the Scientific Committee's agenda.

2. Working papers should be submitted to the Secretariat 45 days prior to the beginning of the meeting and background papers 30 days prior (Table 1).

3. Papers (including reports) received by the Secretariat before the stated deadlines will be processed and made available to Members on the CCAMLR website in advance of the meeting.

4. Papers should be submitted by email to [webmaster@ccamlr.org](mailto:webmaster@ccamlr.org) in Microsoft Word format.

5. Papers (including reports) received after the stated deadlines but before the start of the meeting will be processed and distributed to participants when possible at registration, otherwise during the meeting subject to the requirements of the meeting. These papers will be placed on the CCAMLR website as soon as practically possible.

6. Papers submitted after the start of the meeting will not be accepted for consideration unless specifically agreed by the Scientific Committee due to exceptional circumstances notified to the Chair prior to the meeting.

7. Each working paper and background paper should include a title/cover page and an abstract. The title/cover page of each paper should contain:

- (i) reference to the meeting to which the paper is submitted (e.g. SC-CAMLR-XXIII);

8. Papers should be kept brief to:
