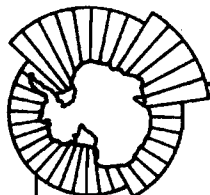

First of all, it is my pleasure after a long while to get in touch with you again, this time with an official request. I trust you are doing fine and things are well underway in Hobart!

During the past two weeks we had the ICES Annual Science Conference, this year in Maastricht/NL. In preparing the 2008 ASC, to be held in Halifax, Canada, the ICES Consultative Committee. (ConC) has discussed the Theme Sessions for presentations and we have solicited possible co-sponsorship for the now total of 16 Sessions. One of these is "The role of sea ice for polar ecosystems" which was spawned by our Oceanography Committee. ConC has instructed me to inquire for possible co-sponsorship for this particular session by CCAMLR.
