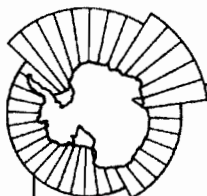

Twenty-sixth Meetings of CCAMLR

In accordance with the Rules of Procedure, Members are invited to attend the Twenty-sixth Meetings of the Commission for the Conservation of Antarctic Marine Living Resources and the Scientific Committee which will be held in Hobart, Australia, from 22 October to 2 November 2007.

The venue for these meetings is at the CCAMLR Headquarters which is located at 181 Macquarie Street, Hobart.

A preparatory meeting, for Heads of Delegation only, will be held on Sunday 21 October at 1600 h. This will be followed by a meeting for Scientific Committee Representatives only.

Members are reminded of their obligation to notify the Secretariat in advance of the meeting, the names of their representatives, alternate representatives and advisers. Members' attention is drawn to the requirement that, to facilitate visa processing, official Commission contacts should provide the Secretariat with a Personal Information Form for each person nominated to attend the meeting. This form is to be submitted at least two months prior to the person's intended date of departure. The form and revised instructions concerning visa requirements for entry into Australia were provided to Members in COMM CIRC 07/54–SC CIRC 07/27. This information is also available on the Commission and Scientific Committee 'Members Only' pages of the CCAMLR website.

Attached is an Information Note which includes details on the meeting venue, registration, travel arrangements and accommodation.

Agendas

The attached Preliminary Agendas for the Commission and the Scientific Committee have been prepared in accordance with Rule 15 of the Commission's Rules of Procedure and Rule 5 of the Scientific Committee's Rules of Procedure respectively.

Attached are the guidelines for submission of papers to both the Commission and Scientific Committee. Members' attention is drawn to the deadlines set out therein.

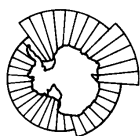
Meeting Schedule

CCAMLR-XXVI INFORMATION NOTE

The following information is provided by the Secretariat for the use of Member and Observer delegations to the Twenty-sixth Meetings of the Commission and the Scientific Committee for the Conservation of Antarctic Marine Living Resources.

1. DATES

The meetings of both the Commission and Scientific Committee will be convened during the period from 22 October to 2 November 2007.

There will be a meeting for Heads of Member Delegations only at 1600 h on Sunday 21 October, to be followed by a meeting for Scientific Committee Representatives only.

2. VENUE:

CCAMLR Headquarters, 181 Macquarie Street, Hobart, Tasmania, Australia (see attached map).

Car parking:

Please note that parking on the Headquarters site is limited. Delegates are requested to park their vehicles offsite. The Market Place Car Park (3–4 Market Place) is open 24 hours, and the Village Cinema Car Park (179–181 Collins Street) is open from 0645 h to 2400 h. There are other parking stations nearby with shorter opening hours. The Secretariat will provide further details if required.

**PRELIMINARY ANNOTATED AGENDA FOR THE
TWENTY-SIXTH MEETING OF THE COMMISSION FOR THE
CONSERVATION OF ANTARCTIC MARINE LIVING RESOURCES¹**

1. Opening of the meeting

The meeting will open at 0900 h on Monday, 22 October 2007.

The Chair of the Commission (Mr P. Amutenya, Namibia) will welcome delegates from CCAMLR Members as well as observers from CCAMLR Acceding States. The Chair will also welcome observers from non-Contracting Parties and international organisations invited in accordance with the decision taken last year (CCAMLR-XXV, paragraphs 19.1 to 19.3).

The Chair will introduce His Excellency the Honourable William Cox AC RFD ED, Governor of Tasmania, who will address the meeting.

2. Organisation of the meeting

Directly following the opening of the meeting, the Chair will deal with procedural matters only before adjourning the Commission to allow the Scientific Committee, SCAF and SCIC to carry out their work.

(i) Adoption of the agenda

The Preliminary Agenda for the Twenty-sixth Meeting of the Commission has been prepared and distributed in accordance with Rule 15 of the Commission's Rules of Procedure. A Provisional Agenda will be prepared, taking account of Members' additions and comments, and distributed on 7 September 2007 in accordance with Rule 17 of the Rules of Procedure.

The annotated agendas of SCAF and SCIC are appended.

¹ Abbreviations used throughout this agenda are SCAF (Standing Committee on Administration and Finance), SCIC (Standing Committee on Implementation and Compliance) and JAG (Joint Assessment Group).

(ii) Report of the Chair

The Chair will report on intersessional activities.

3. Finance and administration

(i) Report of SCAF

The Annotated Agenda of the SCAF meeting is given in Appendix A. The report of the meeting will be introduced by its Chair. The detailed findings and recommendations of the report will be considered by the Commission under subitems (ii) to (viii) below, as well as under other relevant agenda items.

(ii) Audited Financial Statements for 2006

The Commission will decide whether to accept the audited Financial Statements for 2006 in accordance with Financial Regulation 12.1.

(iii) Audit requirement for the 2007 Financial Statements

The Commission will confirm that a full audit of the 2007 Financial Statements will be required as agreed last year (CCAMLR-XXV, paragraph 3.3), or whether a review audit alone will suffice.

(iv) Secretariat matters

The Commission will receive the advice of SCAF on various financial and administrative matters affecting the Secretariat since CCAMLR-XXV. This will include consideration of interpreting services for SCIC (CCAMLR-XXV, paragraphs 3.11 to 3.15).

(v) Contingency Fund

The SCAF Chair will report to the Commission on expenditure from, or any requests for use of, the Contingency Fund.

(vi) Special funds

The Commission will receive the advice of SCAF, SCIC and the CDS Fund Review Panel on the use of the CDS Fund and other special funds during the 2006/07 intersessional period, and on any proposals received for use of the funds over the forthcoming intersessional period.

(vii) Budgets for 2007, 2008 and 2009

Based on advice from SCAF, the Commission will consider proposed changes to the adopted budget for 2007, adopt the budget for 2008 and note a forecast budget for 2009.

(viii) Members' contributions

Following its request in 2005 (CCAMLR-XXIV, paragraph 3.23), the Commission will receive advice from SCAF on the application of Financial Regulation 5.6 in respect of the timing of Members' contribution payments.

4. Scientific Committee

The Chair of the Scientific Committee will introduce the report of the Twenty-sixth Meeting of the Scientific Committee containing advice and recommendations to the Commission in accordance with the Convention's objectives. The Commission will consider the general recommendations, advice, research and data requirements of the Scientific Committee.

The Commission will also consider substantive matters related to ecosystem monitoring and management, harvested species, scientific research exemption, Secretariat supported activities, publications and the Scientific Committee's activities planned for 2007/08. This will include advice and recommendations on:

- krill fishing (CCAMLR-XXV, paragraphs 4.20 to 4.39), including operation of the continuous fishing system (CCAMLR-XXV, paragraphs 4.40 to 4.44);
- notifications of Members' intention to fish for krill in the 2007/08 season;

- the Joint CCAMLR-IWC Workshop to review information required for ecosystem models being developed to provide management advice on krill predators in the Antarctic marine ecosystem (CCAMLR-XXV, paragraph 4.77);
- future activities of the Scientific Committee and its working groups (CCAMLR-XXV, paragraphs 4.81 and 4.83) and the development of the Scientific Committee's long-term science plan.

Other substantive matters arising from the Scientific Committee will be discussed under other parts of the Commission's agenda: assessment and avoidance of incidental mortality (item 5); marine protected areas (item 6); IUU fishing (item 9); Scheme of International Scientific Observation (item 10); new and exploratory fisheries (item 11); fisheries management and conservation under conditions of uncertainty (item 13); cooperation with other international organisations (item 16); and participation in the International Polar Year (item 20(i)).

5. Assessment and avoidance of incidental mortality

The Commission's discussions will be conducted under the following subitems and will take account of the Scientific Committee's advice and recommendations.

(i) Marine debris

The Commission will consider the advice of the Scientific Committee on the biological impact of marine debris, and on the evaluation of scientific data from Members' surveys of beached marine debris and from observations of the incidence and impact of marine debris on marine living resources in the Convention Area.

(ii) Incidental mortality of seabirds and marine mammals during fishing operations

The Scientific Committee's report will contain advice on the incidental mortality of seabirds and marine mammals during fishing operations.

In particular, the Scientific Committee will report on recent seabird and marine mammal research, developments in by-catch mitigation methods, education initiatives, cooperation with RFMOs and other subjects of importance to the

elimination of incidental mortality of seabirds and marine mammals in CCAMLR fisheries. Compliance with Conservation Measures 25-02 'Minimisation of the incidental mortality of seabirds in the course of longline fishing or longline fishing research in the Convention Area' and 25-03 'Minimisation of the incidental mortality of seabirds and marine mammals in the course of trawl fishing in the Convention Area' will be reviewed.

6. Marine Protected Areas

The Commission will consider recent progress in addressing considerations associated with the question of Marine Protected Areas in the Convention Area (CCAMLR-XXIV, paragraphs 4.12 to 4.18; CCAMLR-XXV, paragraphs 6.1 to 6.6). The discussion will consider:

(i) Current activities

Particular emphasis will be given to results and advice emanating from the Bioregionalisation Workshop held in August 2007 (CCAMLR-XXV, paragraphs 6.2 and 6.6).

(ii) Future developments.

7. Implementation and compliance

(i) Report of SCIC

The Annotated Agenda of the SCIC meeting is given in Appendix B. The Chair of SCIC will introduce the report of the Committee's meeting, and detailed findings and recommendations will be considered by the Commission under subitems (ii) and (iii) below, as well as under other relevant agenda items.

(ii) Compliance with conservation measures

The Commission will review SCIC's advice on the implementation of compliance-related provisions of conservation measures in force, particularly in respect of tagging requirements (CCAMLR-XXV, paragraphs 7.8

and 11.24), Vanuatu's involvement in krill fishing (CCAMLR-XXV, paragraphs 7.16 to 7.20) and the status of the IUU Vessel Lists (CCAMLR-XXV, paragraph 9.53) (to also be discussed under Item 9(iii) below).

(iii) Compliance evaluation procedure

The Commission will receive advice from SCIC on the intersessional work to develop a procedure for evaluating compliance with conservation measures in force (CCAMLR-XXV, paragraphs 7.21 to 7.30).

8. Catch Documentation Scheme for *Dissostichus* spp. (CDS)

(i) Report of SCIC

The relevant advice from SCIC on the operation and performance of the CDS will be presented and the subitems below will be addressed.

(ii) CDS annual report

The operation of the CDS in 2006/07 will be reviewed. The Commission will consider the advice received from SCIC and decide whether any aspect of the CDS requires revision in order to improve its efficiency.

(iii) E-CDS

The Commission will review the ongoing development and use of the E-CDS and intersessional work undertaken on its improvement (CCAMLR-XXV, paragraphs 8.3 and 8.4 and Annex 5, paragraph 4.7).

9. Illegal, unregulated and unreported (IUU) fishing in the Convention Area

(i) Report of SCIC

The relevant advice from SCIC in relation to IUU fishing will be presented and the subitems below will be addressed.

(ii) Current level of IUU fishing

The Commission will consider the current levels and trends in IUU fishing activities in the Convention Area as reported by the Secretariat and considered by WG-FSA, the Scientific Committee and SCIC. The Commission will also consider whether the current compliance-related conservation measures effectively meet CCAMLR's objectives on the elimination of IUU fishing in the Convention Area. The discussion will also include ongoing work aimed at improving estimation of IUU fishing catch levels (CCAMLR-XXV, paragraph 9.5).

(iii) Review of current measures aimed at eliminating IUU fishing

The Commission will consider the advice of SCIC on the implementation of Conservation Measures 10-06 'Scheme to promote compliance by Contracting Party vessels with CCAMLR conservation measures' and 10-07 'Scheme to promote compliance by non-Contracting Party vessels with CCAMLR conservation measures'. In particular, the Commission will consider SCIC's advice on the IUU Vessel Lists adopted in 2005 and 2006 and the Proposed IUU Vessel Lists for 2007. The IUU Vessel Lists for 2007 will be adopted. The Commission will also consider any developments in respect of efforts by Members and the Secretariat to engage non-Contracting Parties on the issue of IUU fishing.

The Commission will also consider the status of the 2006 Contracting Party IUU Vessel List and its application in respect of the *Volna* (CCAMLR-XXV, paragraph 9.53). Further options to combat IUU fishing in the Convention Area, particularly in Subarea 58.4, will also be considered (CCAMLR-XXV, paragraph 11.16).

10. Scheme of International Scientific Observation

A summary of scientific observations undertaken in the 2006/07 season will be presented.

The Commission will receive advice from the Scientific Committee on the implementation of the scheme and consider actions recommended by SCIC and the Scientific Committee to ensure that the scheme continues to meet its objectives and operates in the most efficient and effective way.

11. New and exploratory fisheries

Last year the Commission approved exploratory fisheries for toothfish in Subareas 48.6, 88.1 and 88.2 and Divisions 58.4.1, 58.4.2, 58.4.3a and 58.4.3b in the 2006/07 season (CCAMLR-XXV, paragraphs 11.20 and 11.21). There were no notifications for new fisheries in 2006/07. The Commission will review the operation of these fisheries and the management measures in force.

The Commission will consider notifications from Members for new and exploratory fisheries in the 2007/08 season, received in accordance with Conservation Measures 21-01 'Notification that Members are considering initiating a new fishery' and 21-02 'Exploratory fisheries' respectively.

The Commission will consider the Scientific Committee's advice and recommendations relating to new and exploratory fisheries, including:

- developments in the tagging and research requirements in exploratory fisheries (CCAMLR-XXV, paragraph 11.24);
- review of catch limits in SSRUs (CCAMLR-XXV, paragraphs 11.21 to 11.23);
- further development of CCAMLR's regulatory framework, including the steps required for moving from new and exploratory fisheries to assessed fisheries (CCAMLR-XXIV, paragraph 10.21);
- progress in reviewing potentially destructive fishing practices, including application of Conservation Measures 21-01 and 21-02 (CCAMLR-XXV, paragraphs 11.25 to 11.36) and the use of bottom trawling gear in the high-seas areas of the Convention Area (CCAMLR-XXV, paragraph 11.37);
- submission of new or exploratory fisheries notifications in accordance with the standard format agreed in 2006 (CCAMLR-XXV, paragraph 11.40).

12. Conservation measures

(i) Review of existing measures

The Commission will review existing conservation measures in the light of the Scientific Committee's advice and experience gained by Members in implementing measures in the 2006/07 season.

The Commission will consider SCIC's advice on work undertaken on the development of methods for assessing compliance with conservation measures and plans for future work.

Where appropriate, the Secretariat will report on proposals for the revision of existing measures which were prepared intersessionally in consultation with Members.

(ii) Consideration of new measures and other conservation requirements

Conservation measures not already addressed in the course of the Commission's deliberations under other agenda items or under subitem 12(i) will be discussed under this subitem. In particular, it will include any progress in revising the krill catch limit for Division 58.4.2 (CCAMLR-XXV, paragraph 12.69) and with respect to further revision of the System of Inspection (CCAMLR-XXV, paragraph 3.48).

13. Fisheries management and conservation under conditions of uncertainty

The Commission will consider advice provided by the Scientific Committee. It will also consider development of a proposal to expand the current Fishery Plan concept endorsed by the Commission into a forward-looking management plan ('Fisheries Management Plan') (CCAMLR-XXV, paragraphs 13.7 and 13.11).

14. Data access and security

The Commission will keep under review the access and security of CCAMLR data.

15. Cooperation with other elements of the Antarctic Treaty System

(i) Cooperation with Antarctic Treaty Consultative Parties

CCAMLR was represented at the Thirtieth Antarctic Treaty Consultative Party Meeting (ATCM-XXX) (30 April to 11 May 2007, New Delhi, India). The Executive Secretary will report on the meeting.

The Executive Secretary also participated in the Tenth Meeting of the Committee on Environmental Protection (CEP-X) on behalf of the Chair of the Scientific Committee who was unable to attend due to ill health. The Executive Secretary will provide a report on the meeting.

The CEP Observer will also be invited to report on recent CEP initiatives of interest to CCAMLR.

Future cooperation and participation in the meetings of the ATCM and CEP in 2008 will be discussed.

(ii) Cooperation with SCAR

The report of the Scientific Committee will contain results of its deliberations on cooperation with SCAR.

In addition, the CCAMLR Observer to SCAR and the SCAR Observer to CCAMLR will be invited to report on recent SCAR initiatives of interest to CCAMLR.

Future cooperation and participation in the meetings of SCAR and its relevant subsidiary bodies in 2008 will be discussed.

(iii) Assessment of proposals for Antarctic Specially Protected Areas and Specially Managed Areas, which include marine areas

The Commission will consider the advice of the Scientific Committee on the assessment of draft management plans proposed under the Environmental Protocol to the Antarctic Treaty, for protected areas with marine area components, and submitted to CCAMLR for approval.

16. Cooperation with other international organisations

(i) Reports of observers from international organisations

The following international organisations have been invited to attend CCAMLR-XXVI as observers: ACAP, ASOC, CCSBT, CITES, COLTO, CPPS, FAO, FFA, IATTC, ICCAT, IOC, IUCN, IWC, SCOR, SEAFO, SPC and UNEP.

Their reports will have been tabled. Representatives of these and other organisations present at the meeting will be invited to present any key items from their reports. The reports from the CEP and SCAR Observers will have been dealt with under items 15(i) and 15(ii) above.

(ii) Reports from CCAMLR representatives at meetings of international organisations in 2006/07

Reports from CCAMLR representatives at the 2006/07 meetings of various international organisations (CCAMLR-XXV, paragraph 16.49) will be received.

(iii) Cooperation with CITES

The Commission will review developments in cooperation between CCAMLR and CITES on matters of mutual interest, subject to CCAMLR-XXII, paragraphs 14.18 and 14.19 and CCAMLR-XXV, paragraph 16.36.

(iv) Cooperation with CCSBT

The Commission will review developments in cooperation between CCAMLR and CCSBT following discussions at CCAMLR-XXIV and CCAMLR-XXV (CCAMLR-XXIV, paragraphs 15.20 to 15.23; CCAMLR-XXV, paragraphs 16.37 to 16.44).

(v) Cooperation with WCPFC

The Commission will review recent developments concerning a potential memorandum of understanding between CCAMLR and the Western-Central Pacific Fisheries Commission (WCPFC) (COMM CIRC 07/50). A number of Members have requested a full discussion on this agenda item.

(vi) Partnership in FIRMS

CCAMLR–FIRMS activities will be reviewed (CCAMLR-XXV, paragraphs 16.45 and 16.46).

(vii) Participation in CCAMLR meetings

Developments arising from discussions at CCAMLR-XXIV and CCAMLR-XXV (CCAMLR-XXIV, paragraphs 15.28 and 15.29; CCAMLR-XXV, paragraphs 16.47 and 16.48) will be considered.

**(viii) Nomination of representatives to meetings
of international organisations in 2007/08**

The Commission will nominate CCAMLR Observers to the 2007/08 meetings of international organisations with which CCAMLR shares a common interest. The Secretariat has compiled a timetable of future meetings of international organisations, to the extent that these are known. The Commission will also endorse similar nominations from the Scientific Committee.

17. Implementation of the objectives of the Convention

Since 1996 the Commission has agreed that specific reflection on the objectives of the Convention continues to be an important requisite of each annual meeting. The Commission will consider proposals submitted for discussion under this item. It will also consider any progress made with respect to the various strategic discussions highlighted at CCAMLR-XXIV (as a consequence of the 2005 CCAMLR Symposium) and CCAMLR-XXV (CCAMLR-XXIV, paragraphs 16.11 to 16.18; CCAMLR-XXV, paragraphs 17.1 to 17.5), particularly in respect of the need to address climate change effects.

18. Election of Vice-Chair of the Commission

In accordance with Rule 8 of the Commission's Rules of Procedure, a Commission Vice-Chair must be elected to serve from the conclusion of the CCAMLR-XXVI until the conclusion of the Commission's 2009 meeting.

19. Next meeting

(i) Invitation of observers

Since 1994 the Commission has addressed the invitation of observers to its next meeting under this agenda item (CCAMLR-XIII, paragraph 13.7). Acceding States, non-Contracting Parties and international organisations to be invited to CCAMLR-XXVII will be identified.

(ii) Date and location

The Twenty-seventh Meeting of the Commission will be held at the CCAMLR Headquarters Building (181 Macquarie Street) in Hobart between 27 October and 7 November 2008.

20. Other business

(i) International Polar Year in 2007/08

The Commission will consider the Scientific Committee's report and advice on CCAMLR-related activities under the auspices of the International Polar Year in 2007/08 (CCAMLR-XXV, paragraphs 20.1 to 20.12).

21. Report of the Twenty-sixth Meeting of the Commission

The report of the Twenty-sixth Meeting will be considered and adopted.

22. Close of the meeting

The meeting is scheduled to close at 1600 h on Friday, 2 November 2007.

**PRELIMINARY ANNOTATED AGENDA FOR THE 2007 MEETING

1. Organisation of the meeting

The Committee will adopt its agenda and consider the optimum way to address it, given the time available and the requirements of SCIC. In an attempt to relieve the time pressure on SCIC, the Heads of Delegation meeting on Sunday, 21 October 2007 may change SCAF's working schedule for this year.

2. Examination of audited Financial Statements for 2006

As required by the Commission, the Auditor performed a review audit on the 2006 Financial Statements (CCAMLR-XXV, paragraph 3.3). No breaches of the Financial Regulations were reported. The Financial Statements, together with the associated audit report, will be presented for acceptance by the Commission. In this regard, note should also be taken of COMM CIRC 07/34.

3. Audit requirement for the 2007 Financial Statements

Under the Financial Regulations, the Commission may authorise a full audit for the 2007 Financial Statements, or may decide that only a review audit will be required. As a review audit was carried out on the 2005 and 2006 Financial Statements, a full audit will be required for the 2007 statements (CCAMLR-XXV, paragraph 3.3).

4. Secretariat Strategic Plan

The Secretariat Strategic Plan to support the work of the Commission and the Scientific Committee was presented to the Commission in 2002. The Commission determined that implementation of the plan would form the basis of the Executive Secretary's annual performance appraisal. The Executive Secretary will present any new developments in this regard.

5. Review of 2007 budget

The expected results of the 2007 budget will be presented for review.

6. Interpreting services for SCIC

At CCAMLR-XXIV, the Heads of Delegations requested the Secretariat to prepare a paper outlining the cost of providing interpreting services to SCIC (CCAMLR-XXIV, Annex 5, paragraph 7.1). The Committee considered this paper and provided advice to the Commission regarding the costs of the proposal, noting that the Commission's current budget was already under considerable pressure, particularly as the result of a higher-than-expected request from the Scientific Committee (CCAMLR-XXV, Annex 4, paragraphs 17 and 18). As many Members supported the simultaneous interpretation services being available to SCIC, the Commission agreed to revisit this issue at its next meeting (CCAMLR-XXV, paragraphs 3.11 to 3.15). The Secretariat will prepare an updated paper for SCAF to consider and provide any necessary advice to the Commission.

7. Wireless computer network

The Secretariat will report on the status of this project.

8. Contingency Fund

As required by the agreed procedures (CCAMLR-XXI, Annex 4, paragraph 21), the Executive Secretary will report on expenditure from the Contingency Fund during the year, together with any other budgetary consequences.

9. Professional Staff salaries

No proposals have been submitted in respect of providing experts to review the Professional Staff salary structure. The Committee will consider how it may wish to proceed on this matter.

10. Budget for 2008

A draft budget for 2008 will be presented. This will be used to prepare a recommended budget for 2008, taking into account SCAF's discussions on financial and administrative issues, as well as advice from the Chairs of the Scientific Committee and SCIC.

(i) Scientific Committee budget

The Chair of the Scientific Committee will be invited to present the Scientific Committee's budget for 2008 and its forecast budget for 2009 so that these may be included in the Commission's overall budgets. She will also be invited to advise SCAF of any other Scientific Committee decisions which would affect the Commission's budget.

(ii) Advice from SCIC

The Chair of SCIC will be invited to present the financial implications of SCIC'S recommendations to the Commission for the Committee's consideration.

11. Multi-year funding of Scientific Committee tasks

At its 2004 meeting, the Commission endorsed the establishment and use of a Special Science Fund to enable deferral of funding to future years for certain Scientific Committee tasks. The Committee will consider any requests from the Scientific Committee for deferral of funds budgeted for expenditure in 2007 to 2008.

12. Members' contributions

(i) Timing of Members' contributions

When revising Financial Regulation 5.6 in 1999, the Commission modified the date by which annual contributions are required to be paid. This revision permits Members who advise their inability to meet the deadline set out in Regulation 5.6 to have an extended deadline of up to 90 days. The

Commission has agreed that the Committee will continue to review this regulation and Members' compliance therewith. The Committee will also consider the need to retain the extended deadline for some Members in 2007.

(ii) Treatment of late payments

As requested by the Commission (CCAMLR-XXIV, paragraph 3.23), the Secretariat presented a paper outlining the measures taken by similar organisations in their treatment of late payment of member contributions for the consideration of SCAF at its 2006 meeting (CCAMLR-XXV, Annex 4 paragraph 33). At the Commission meeting, some Members expressed concern with the subsequent SCAF proposal and the Commission deferred the matter to its next meeting, encouraging those Members with concerns to attend the 2007 SCAF meeting to fully debate the issue (CCAMLR-XXV, paragraph 3.22).

13. Forecast budget for 2009

The Committee will present a forecast budget for 2009 to the Commission for information purposes only.

14. CDS Fund

Any requests for expenditure from the CDS Fund are required to be submitted through the CDS Fund Review Panel (CCAMLR-XX, paragraphs 3.27 and 3.28). The Committee will receive the advice of the panel on expenditure from the fund since the 2006 meeting and proposals received for future expenditure from the fund.

15. Any other business

The Committee will discuss any other business which the Commission may wish to refer to it for consideration.

16. Election of Chair and Vice-Chair of SCAF for 2008 and 2009

In 2005 the Committee reappointed Germany as the Chair of SCAF, and appointed New Zealand as Vice-Chair, until the end of the 2007 meeting. Both the positions of

Chair and Vice-Chair of SCAF will therefore be up for election. Members should note that Germany has now served two terms as Chair and is therefore ineligible for reappointment.

17. Adoption of the report

The Committee will adopt its report to the Commission.

18. Close of the meeting.

States will be invited to present additional information, if any, with respect to inspections undertaken. The Committee will review the operation of the System of Inspection and consider any proposals received on the improvement of the system.

The Committee will review and assess Contracting Parties' implementation of, and compliance with, conservation and management measures adopted by the Commission.

(ii) Compliance evaluation procedure

The Vice-Chair will report on the work of intersessional group established by SCIC to consider further key compliance elements identified by the Secretariat, including development of compliance evaluation criteria and a standard procedure model that can consistently be used to evaluate performance of vessels with conservation measures in force (CCAMLR-XXV, paragraph 7.30 and Annex 5, paragraphs 3.34 and 3.35).

The Committee will discuss the report and consider the organisation of future work required to develop and implement a procedure for the evaluation of compliance with conservation measures in force.

(iii) Proposals for new and revised measures

The Committee will consider any proposals for the revision of current compliance-related conservation measures or the establishment of any additional measures. If an additional measure is required, the Committee will prepare a draft of the measure and submit it for further consideration by the Commission.

3. IUU fishing in the Convention Area

(i) Current level of IUU fishing

The Committee will consider the report on current levels of IUU catches in the Convention Area as prepared by the Secretariat taking into consideration the recommendations of JAG. The Committee will review the estimates of the current levels and trends in IUU fishing activities in the Convention Area and

will consider whether the current enforcement measures effectively meet their objectives on the elimination of IUU fishing in the Convention Area. In particular, special attention will be paid to reports on gillnet fishing by IUU vessels in the Convention Area.

(ii) Procedure for estimation of IUU catches

The Committee will consider the results of intersessional testing by the Secretariat of matrices adopted by JAG and SCIC in 2006 (CCAMLR-XXV, paragraph 9.5 and Annex 5, paragraph 2.20 and Appendix III) which were developed to provide a confidence ranking in respect of individual incidents of IUU fishing.

(iii) IUU Vessel Lists

The Committee will review reports submitted by Contracting and non-Contracting Parties on measures they have taken to avoid any undermining of the effectiveness of CCAMLR conservation measures resulting from activities of their vessels included in the IUU Vessel Lists adopted in 2006. In particular, the Committee will consider additional information submitted by Russia relating to the decision postponed by the Commission in 2006 regarding the inclusion of the vessel *Volna* on the IUU Vessel List (CCAMLR-XXV, paragraph 9.40).

The Committee will also review comments and information received on vessels included in the Provisional List of IUU vessels for 2007 in accordance with Conservation Measures 10-06 and 10-07.

The Committee will prepare recommendations to the Commission on vessels which should be removed from the IUU Vessel Lists adopted in 2006 and on vessels to be retained in the Provisional List of IUU Vessels for 2007.

4. Catch Documentation Scheme (CDS)

The Committee will consider the results of the CDS operation in 2006/07. The Committee will also consider whether any aspect of the CDS requires revision in order to improve its efficiency.

The Committee will consider a report prepared by the Secretariat on the ongoing development and use of the E-CDS which will include intersessional work on improvements to the E-CDS (CCAMLR XXV, paragraph 8.3 and Annex 5, paragraph 4.7).

5. Scheme of International Scientific Observation

The Committee will consider advice from the Scientific Committee on the operational requirements of the scheme, in particular, for the 2007/08 season.

Also taking account of any Scientific Committee advice, the Committee will consider whether revision is required of any of the operational aspects of the scheme.

6. Other business

1. Opening of the meeting

The Chair (Dr E. Fanta, Brazil) will open the meeting and welcome delegations of CCAMLR Members and observers. International organisations invited to the meeting are listed in Agenda Item 10(ii). The organisation of the meeting and in-house arrangements will be discussed.

(i) Adoption of the agenda

The Preliminary Agenda for the Twenty-sixth Meeting of the Scientific Committee has been prepared and distributed in accordance with Rule 5 of the Scientific Committee's Rules of Procedure. A Provisional Agenda will be prepared, taking account of Members' additions and comments, and distributed on 7 September 2007 in accordance with Rule 7 of the Rules of Procedure.

(ii) Report of the Chair

The Chair will report on intersessional activities undertaken since the Twenty-fifth Meeting (SC-CAMLR-XXV).

(iii) Preparation of advice to SCAF and SCIC

In accordance with established practice, the Chair will provide preliminary advice to SCAF and SCIC on matters of relevance to these standing committees which will meet concurrently with the meeting of the Scientific Committee.

The Scientific Committee will conclude its advice to SCAF and SCIC under Agenda Item 12.

2. Advances in statistics, assessments, modelling and survey methods

The Scientific Committee will consider advice from WG-SAM on developments in statistics, assessments and modelling, and from SG-ASAM on acoustic survey and analysis methods.

(i) Advice from WG-SAM

The Co-conveners of WG-SAM (Drs C. Jones, USA and A. Constable, Australia) will present the WG-SAM report, including developments in fish stock assessment methods and the procedure for subdividing krill catch limits in Area 48 amongst small-scale management units.

(ii) Advice from SG-ASAM

The Co-conveners of the third meeting of SG-ASAM (Drs R. O'Driscoll, New Zealand and M. Collins, UK), or their nominated representative, will present the SG-ASAM report, including developments in the use of acoustic data for assessing the biomass of icefish and krill, and the acoustic sampling protocols for CCAMLR-related work during IPY.

(iii) Advice to the Commission

The Scientific Committee will advise the Commission on matters of relevance to the development of statistics, assessments, modelling and survey methods.

3. Ecosystem monitoring and management

The Scientific Committee will consider advice from WG-EMM on ecosystem monitoring, management and assessment.

The Convener of WG-EMM (Dr K. Reid, UK) will present the relevant sections of the WG-EMM report, including information on ecosystem

assessment, krill-centred interactions, krill management procedures, developments in ecosystem models, predator surveys, fish and squid-centred interactions, and consideration of precautionary approaches and ecosystem approaches applied in other parts of the world. This will include arrangements for the joint CCAMLR-IWC workshop scheduled for 2008.

(ii) Management of protected areas

The Scientific Committee will consider the report of the Bioregionalisation Workshop (SC-CAMLR-XXV, paragraph 3.57). The workshop focused on technical developments of methods for bioregionalisation of the Southern Ocean (SC-CAMLR-XXV, paragraph 3.33(i)). Future work on methods for selection and designation of MPAs will be discussed (SC-CAMLR-XXV, paragraph 3.33(ii)).

The Scientific Committee will also consider WG-EMM's advice on matters discussed this year by the Advisory Subgroup on Marine Protected Areas.

(iii) Interactions between WG-EMM and WG-FSA

The Scientific Committee will consider the report from the joint WG-FSA and WG-EMM Workshop on Fisheries and Ecosystem Models in the Antarctic. The Scientific Committee will also consider future work on ecosystem interactions of finfish fisheries and the integration of the work of WG-FSA, WG-EMM and WG-SAM on finfish ecosystem modelling.

(iv) Advice to the Commission

The Scientific Committee will advise on recent developments in relation to ecosystem monitoring and management.

4. Harvested species

(i) Krill resources

(a) Status and trends

Members will be invited to inform the Scientific Committee of recent developments and trends in krill fisheries in the Convention Area. The Secretariat will summarise fishery data reported for the current season.

(b) Advice from WG-EMM

The Convener of WG-EMM (Dr Reid) will present the relevant sections of the WG-EMM report.

(c) Notifications for krill fisheries in the 2007/08 season

Notifications for krill fisheries in the forthcoming 2007/08 season will be reviewed and the advice of WG-EMM considered.

(d) Advice to the Commission

The Scientific Committee will provide management advice.

(ii) Fish resources

(a) Status and trends

Members will be invited to inform the Scientific Committee of recent developments and trends in finfish fisheries in the Convention Area. The Secretariat will summarise fishery data reported for the current season. The report of WG-FSA will contain further information.

(b) Target species

The Convener of WG-FSA (Dr S. Hanchet, New Zealand) will present the sections of the WG-FSA report dealing with the assessment of fish

resources and recommendations on their management. Matters related to new and exploratory fisheries, including notifications for the 2007/08 season, will be discussed under Agenda Item 4(iii).

(c) Advice from WG-FSA

The Scientific Committee will consider the recommendations of WG-FSA dealing with the assessment of fish resources and recommendations on their management.

(d) Advice to the Commission

The Scientific Committee will provide management advice.

(iii) New and exploratory fisheries

(a) New and exploratory fisheries in the 2006/07 season

The Secretariat will summarise fishing activities in new and exploratory fisheries in the 2006/07 season. Information on these fisheries and the deliberations of WG-FSA on these matters will be reviewed.

Notifications for new and exploratory fisheries in the forthcoming 2007/08 season will be reviewed and the advice of WG-FSA considered.

The Scientific Committee will provide advice concerning new and exploratory fisheries.

The Commission has also requested that the Scientific Committee:

- review the use of bottom trawling gear in high-seas areas of the Convention Area, including with respect to relevant criteria for determining what constitutes significant harm to benthos and benthic communities in the Convention Area (CCAMLR-XXV, paragraph 11.37);
- investigate the potential impacts of fishing on shark species in the Convention Area (CCAMLR-XXV, paragraph 11.38)

(iv) Crab resources

(a) Status and trends

Members will be invited to inform the Scientific Committee of recent developments and trends in the crab fisheries in the Convention Area, and their intentions to fish in the 2007/08 season. The Secretariat will summarise fishery data reported for the current season.

(b) Advice from WG-FSA

The Convener of WG-FSA (Dr Hanchet) will present the results of WG-FSA's deliberations on crab resources.

(c) Advice to the Commission

The Scientific Committee will provide management advice.

(v) Squid resources

(a) Status and trends

Members will be invited to inform the Scientific Committee of recent developments and trends in squid fisheries in the Convention Area. The Secretariat will summarise fishery data reported for the current season. Notifications for the exploratory fishery in Subarea 48.3 in the 2007/08 season will be reviewed and the advice of WG-FSA considered.

(b) Advice from WG-FSA

The Convener of WG-FSA (Dr Hanchet) will present the results of WG-FSA's deliberations on squid resources.

(c) Advice to the Commission

The Scientific Committee will provide management advice.

(vi) Fish and invertebrate by-catch

(a) Status and trends

Members will be invited to inform the Scientific Committee of recent developments and trends in by-catch from fisheries in the Convention Area. The Secretariat will summarise by-catch data reported for the current season.

(b) Advice from WG-FSA

The Scientific Committee will consider the recommendations of WG-FSA on developments in fishing methods, education and other matters relevant to by-catch in CCAMLR fisheries.

(c) Advice to the Commission

The Scientific Committee will provide management advice.

5. Incidental mortality

(i) Incidental mortality of seabirds and marine mammals arising from fisheries

The Co-conveners of ad hoc WG-IMAF (Dr K. Rivera, USA and Mr N. Smith, New Zealand) will report on the intersessional activities of WG-IMAF and the group's meeting conducted as part of WG-FSA.

The Scientific Committee will consider the recommendations of WG-IMAF and WG-EMM on research priorities, developments in fishing methods, education and other matters of importance to the elimination of incidental mortality of seabirds and marine mammals arising from fisheries.

(ii) Advice to the Commission

The Scientific Committee will provide management advice.

6. Additional monitoring and management issues

(i) Marine debris

Members are required to report results of marine debris surveys and observations on the incidence and impact of marine debris on Antarctic marine living resources according to standard reporting requirements adopted at CCAMLR-XX (paragraphs 6.1 to 6.5). Based on Members' reports received, an annual summary report on the status and trends in marine debris-related observations will be submitted by the Secretariat.

(ii) Marine mammal and bird populations

WG-EMM has been planning a workshop to develop regional estimates of land-based predator abundance and demand in Area 48 (SC-CAMLR-XXIV, paragraph 3.32; SC-CAMLR-XXIV, Annex 4, paragraph 6.9). This workshop is scheduled for 2008 (SC-CAMLR-XXV, paragraph 3.28(v)).

The Scientific Committee will consider further advice from WG-EMM on progress with preparation for the workshop.

(iii) Advice to the Commission

The Scientific Committee will provide management advice concerning marine debris and its impact on Antarctic marine living resources, and further work required to develop regional estimates of land-based predator abundance and demand in Area 48.

7. CCAMLR Scheme of International Scientific Observation

(i) Scientific observations

The results of scientific observations carried out in accordance with the Scheme of International Scientific Observation in the 2006/07 season have been discussed by WG-EMM and WG-FSA and reported to the Scientific Committee. The Secretariat will summarise all observation programs undertaken and data received.

The operation of the scheme during the 2006/07 season will be reviewed.

The Scientific Committee will consider scientific objectives and priorities for the deployment of CCAMLR international scientific observers and, in particular, the requirements for collecting scientific observations on board vessels fishing for krill (SC-CAMLR-XXV, paragraph 2.22(ii)).

At its last meeting, the Scientific Committee noted that the quality and accuracy of observations could be improved by adopting a standard approach to education and training for observers (SC-CAMLR-XXV, paragraph 2.11). As requested, the Secretariat corresponded with Members intersessionally and prepared an overview report on national observer education and observer training programs. The Scientific Committee will consider the report and discuss further work required to develop an approach for achieving a common level of observer education and training.

The reports of WG-EMM and WG-FSA will contain recommendations to the Scientific Committee on these matters.

(ii) Advice to the Commission

The Scientific Committee will advise the Commission on matters of relevance to the implementation of the scheme and its objectives.

Consideration will also be given to the general operational requirements of the scheme for the forthcoming season so as to assist the Chair in preparing advice to SCIC.

8. Management under conditions of uncertainty about stock size and sustainable yield

The Scientific Committee will consider the recommendations of WG-FSA and WG-EMM regarding the Regulatory Framework for managing CCAMLR fisheries, and the development of management strategy evaluations. The Scientific Committee will also consider the further development of a proposal for fishery management plans (CCAMLR-XXV, paragraph 13.11).

WG-FSA will also report to the Scientific Committee on IUU catch estimates used for stock assessment purposes, and recent trends in IUU fishing activities as prepared by the Secretariat and considered by WG-FSA. The IUU catch estimates were prepared by the Secretariat taking into account the recommendations of JAG in 2006. The Commission has requested that the Scientific Committee and WG-FSA develop likely catch rate distributions for IUU fishing vessels by area using data from licensed vessels, and determine credible ranges for IUU estimates (CCAMLR-XXV, paragraph 13.5).

9. Scientific research exemption

The Scientific Committee will review available information relevant to Conservation Measure 24-01, and consider Members' notifications for scientific research surveys in 2007/08.

The Scientific Committee will provide management advice, as appropriate.

10. Cooperation with other organisations

(i) Cooperation with the Antarctic Treaty System

The Scientific Committee will consider the report on the Tenth Meeting of the Committee on Environmental Protection to the Antarctic Treaty (CEP).

The Scientific Committee will discuss cooperation with SCAR based on reports received from the SCAR Observer and the CCAMLR Liaison Officer to SCAR.

(ii) Reports of observers from other international organisations

Reports will be received from representatives of international organisations present as observers at the Scientific Committee meeting. Those invited include: ACAP, ASOC, CCSBT, CEP, CITES, COLTO, CPPS, FAO, FFA, IATTC, ICCAT, IOC, IUCN, IWC, SCAR, SCOR, SPC and UNEP.

(iii) Reports of representatives at meetings of other international organisations

Reports will be received from representatives nominated by the Scientific Committee to attend meetings of other international organisations during 2006/07 (SC-CAMLR-XXV, paragraph 9.25).

(iv) Future cooperation

The Scientific Committee will discuss the further development of its cooperation with other international organisations and consider any proposals for cooperation received by the Scientific Committee under subitems (i) and (ii) above.

Observers will be nominated to participate in meetings of other international organisations in 2007/08. A calendar of known international meetings of interest to the Scientific Committee has been compiled by the Secretariat.

The Scientific Committee will consider the invitation of observers from international organisations to the next meeting of the Scientific Committee and to its working groups during the 2007/08 intersessional period.

11. Budget for 2008 and forecast budget for 2009

The financial implications of decisions taken during the meeting will be used to prepare a detailed Scientific Committee budget for 2008. This budget will be based on the costs of ongoing projects and new proposals. A forecast budget for 2009 will also be discussed.

In developing its budget, the Scientific Committee will need to consider the working groups' requirements for invited experts and other contracted work, including terms of reference, costing and expected outputs and reporting. The Scientific Committee will also review the Special Science Fund and its requirements for multi-year funding.

12. Advice to SCIC and SCAF

The Scientific Committee will summarise for the Commission its recommendations to SCIC and SCAF on matters relating to their work.

13. Secretariat supported activities

(i) Data management

The Scientific Committee will review the Data Manager's report on the Secretariat's requirements for data management and measures taken to maintain the integrity of the CCAMLR database.

(ii) Publications

The 14th volume of *CCAMLR Science* will be published prior to CCAMLR-XXVI. The Chair of the Editorial Board will advise of any changes, if required, to the editorial policy of *CCAMLR Science*.

Other CCAMLR documents published in 2007 include:

- *Report of the Twenty-fifth Meeting of the Scientific Committee*
- *CCAMLR Scientific Abstracts 2006* (electronic version only)
- *Statistical Bulletin*, Vol. 19 (hardcopy and electronic version)

The Scientific Committee will advise the Commission on future CCAMLR publication requirements.

14. Scientific Committee activities

(i) Coordination of the work of the Scientific Committee and its working groups

Following the formation of WG-SAM in 2006, the Scientific Committee agreed to establish a long-term science plan to set the priorities of WG-SAM, WG-EMM, WG-FSA, ad hoc WG-IMAF and its other groups including SG-ASAM (SC-CAMLR-XXV, paragraph 13.13). The Scientific Committee will consider the recommendations from conveners on the future work of their groups. The Scientific Committee will revise its priorities and timetable for future work, and establish a long-term science plan.

(ii) Intersessional activities

The intersessional activities of the Scientific Committee in 2007/08 will be discussed and planned. This will include identifying the dates and venues for meetings of working groups and other groups, the timing of data submission to the Secretariat, and a schedule of agreed actions to be undertaken by the Chair, conveners of working groups, Members and the Secretariat.

The Scientific Committee may also wish to outline a schedule of agreed activities planned for 2008/09 and beyond.

(iii) CCAMLR-IPY projects

The Scientific Committee will review activities planned during the 2007/08 International Polar Year. The Co-conveners of the CCAMLR-IPY Steering Group (Mr S. Iversen, Norway and Dr Fanta, Chair of the Scientific Committee) will report on the 2007 planning and recent developments in CCAMLR-IPY activities. The Scientific Committee will advise the Commission on these matters.

(iv) Joint CCAMLR-IWC workshop

The Scientific Committee will review progress made to hold a joint CCAMLR-IWC workshop to review information required for ecosystem models being developed to provide management advice on krill predators in the Antarctic marine ecosystem.

(v) Invitation of observers to the next meeting

The Scientific Committee will consider the invitation of observers to its next annual meeting and the intersessional meetings of its working groups.

(vi) Invitation of experts to the meetings of working groups

On the basis of advice from working group conveners and in accordance with Rule 2 of the Rules of the Scientific Committee, the Scientific Committee will decide whether invitations should be extended to scientists and ‘experts’ to attend intersessional meetings of its working groups.

(vii) Next meeting

The next meetings of the Scientific Committee and the Commission to be held at CCAMLR Headquarters in Hobart from 27 October to 7 November 2008.

15. Election of Vice-Chair of the Scientific Committee

In accordance with Rule 8 of the Rules of Procedure of the Scientific Committee, an election will be held for one of the two Vice-Chairs of the Scientific Committee for a term of two regular meetings (2008 and 2009).

**SUBMISSION OF PAPERS TO MEETINGS
OF THE COMMISSION**

SUBMISSION OF PAPERS TO MEETINGS OF THE COMMISSION*

These rules aim to ensure that papers are submitted in sufficient time and in an appropriate form for delegates to be able to read them and absorb their contents before matters contained therein are addressed. This will also enable the substance of each paper to be given due and equal consideration.

All papers considered by the Commission to support the taking of decisions are denominated 'working papers'. Papers provided for background information only are 'background papers'.

2. Working papers require translation into the four official languages. The deadline for submission to the Secretariat is 45 days prior to the beginning of the meeting (Table 1), to allow for processing, including translation.

3. It is usual that the substance of any paper will be included in the main text. Therefore, to avoid undue cost and delay of translation, only the main body of text will be translated and not any appendices or attachments.

4. Background papers, including reports from observers to the meeting, should be submitted to the Secretariat no later than 30 days prior to the beginning of the meeting (Table 1). These are made available to delegates in the language of submission.

5. Papers should be submitted by email to webmaster@ccamlr.org in Microsoft Word format.

6. Papers received by the Secretariat by the stated deadlines will be processed and made available to Members on the CCAMLR website in advance of the meeting.

7. Papers received after the stated deadlines but before 15 days prior to the beginning of the meeting will be processed and distributed to participants at registration in the language of submission, as well as being placed on the website. Translation of working papers will be possible only to the extent that the length of the paper and the date of submission permit.

* Members are reminded to also submit 'Reports on Members' Activities in the Convention Area' no later than 30 days prior to the beginning of the meeting, in accordance with the details provided in Appendix A.

8. Papers received later than 15 days after the stated deadlines but before the start of the meeting will be processed and distributed to participants, if possible, at registration, otherwise during the meeting, subject to the requirements of the meeting.

9. Papers submitted after the beginning of the meeting will not be accepted unless the Chair of the meeting considers that they are of sufficient importance and that delegates will have enough time to give them adequate consideration before the relevant agenda item is discussed. In the case of working papers, translation will depend on the prioritisation of all translation work during the meeting, as determined by the Executive Secretary.

10. Background documents prepared by Member delegates during the meeting in response to identified requirements must be submitted by, or on behalf of, the Head of Delegation and will be processed and distributed as quickly as possible.

11. Each working paper and background paper should include a title page and an abstract. The title page should contain:

- (i) reference to the meeting to which the paper is submitted (e.g. in 2007, CCAMLRL-XXVI);
- (ii) the specific agenda item number(s) to which the paper refers;
- (iii) the title of the paper;
- (iv) the name of the Member/organisation, and of the author(s) if applicable, submitting the paper to the meeting;
- (v) the following disclaimer:

‘This paper is presented for consideration by CCAMLRL and may contain unpublished data, analyses, and/or conclusions subject to change. Data in this paper shall not be cited or used for purposes other than the work of the CCAMLRL Commission, Scientific Committee or their subsidiary bodies without the permission of the originators and/or owners of the data.’

12. The main body of text should not exceed five A4 pages with a maximum of 10 pages of additional information.

REPORTS OF MEMBERS' ACTIVITIES IN THE CONVENTION AREA

These reports are requested from Members in order to:

- (i) keep the Commission and the Scientific Committee informed in a concise format on the scope and variety of activities undertaken annually by each Member in support of the Convention objectives and, in particular, on the implementation of decisions taken by the Commission and the Scientific Committee;*
- (ii) widely publicise the abovementioned activities of CCAMLR by placing these reports on a public access page of the CCAMLR website.*

Reports of Members' Activities should cover the intersessional period since the previous meeting of the Commission and comprise summary information* on the following items:

1. Fishery-related activities:

- (a) fisheries undertaken, in what areas and periods, as well as the total catch by species, and information of planned fishing activities for the year ahead;
- (b) participation in the Scheme of International Scientific Observation (the number of observers deployed, fisheries and areas covered).

2. Compliance and enforcement:

- (a) advice on existing legal or administrative procedures used to annually give effect to the implementation of the CCAMLR conservation measures;
- (b) participation in the CCAMLR System of Inspection including the number of inspectors designated and vessels inspected;

- (c) significant diplomatic demarches made to further cooperation with non-Contracting Parties.

3. Research activities in relation to marine living resources and the CCAMLR Ecosystem Monitoring Program:

- (a) research surveys and study programs undertaken by major topics, species and study areas;
- (b) cooperation in research surveys and programs with other CCAMLR Members;
- (c) participation in the CCAMLR Scheme of International Scientific Observation, including the number of observers designated and deployed.

4. Research activities on the assessment and avoidance of incidental mortality of Antarctic marine living resources:

- (a) research on the assessment of levels of marine debris pollution in the Convention Area and its biological impact on Antarctic marine living resources;
- (b) research on the reduction and avoidance of incidental mortality of seabirds and marine mammals in fishing operations;
- (c) list of surveys of beached marine debris which have been carried out.

5. Other activities, if not included above, in pursuance of the decisions and recommendations of the Commission and the Scientific Committee.

PART I

SUBMISSION OF PAPERS TO MEETINGS OF THE SCIENTIFIC COMMITTEE

Contracting Parties are invited to submit for consideration at meetings of the Scientific Committee, working papers¹ and background papers related to specific items of the Scientific Committee's agenda.

2. Working papers should be submitted to the Secretariat 45 days prior to the beginning of the meeting and background papers 30 days prior (Table 1). SC-CAMLR working and background papers which are to be considered at working group meetings must be submitted to those groups in accordance with their document submission deadlines (see Part II).

3. Papers (including reports) received by the Secretariat before the stated deadlines will be processed and made available to Members on the CCAMLR website in advance of the meeting.

4. Papers should be submitted by email to webmaster@ccamlr.org in Microsoft Word format.

5. Papers (including reports) received after the stated deadlines but before the start of the meeting will be processed and distributed to participants when possible at registration, otherwise during the meeting subject to the requirements of the meeting. These papers will be placed on the CCAMLR website as soon as practically possible.

6. Papers submitted after the start of the meeting will not be accepted for consideration unless specifically agreed by the Scientific Committee due to exceptional circumstances notified to the Chair prior to the meeting.

7. Each working paper and background paper should include a title page and an abstract. The title page of each paper should contain:

- (i) reference to the meeting to which the paper is submitted (e.g. SC-CAMLR-XXVI);
- (ii) the specific agenda item number(s) to which the paper refers;
- (iii) the title of the paper;
- (iv) the name of the Member/delegation/organisation, and the name of the author(s) if applicable, submitting the paper to the meeting;
- (v) the CCAMLR-approved disclaimer:

‘This paper is presented for consideration by CCAMLR and may contain unpublished data, analyses, and/or conclusions subject to change. Data in this paper shall not be cited or used for purposes other than the work of the CCAMLR Commission, Scientific Committee or their subsidiary bodies without the permission of the originators and/or owners of the data.’

The synopsis pro forma in Appendix B is applicable only to working group papers. It is not required for Scientific Committee papers.

8. Papers should be kept brief to:

- (i) ensure that the substance of papers is given due and equal consideration;
- (ii) facilitate translation of working papers;
- (iii) keep to a minimum the overall amount of reading required of delegates.

If possible, the overall volume of each paper should not exceed 15 standard A4 pages.

9. If a paper is intended for consideration for publication in *CCAMLR Science*, it should be accompanied by the form provided in Appendix A. It is the responsibility of the author(s) to ensure that the paper is ready for immediate review (in terms of quality of English expression and figures etc.) following acceptance by the Editorial Board.

10. If at a later date a paper is accepted for publication elsewhere, the author(s) should notify CCAMLR of these publication details by 1 March of the year following its submission to CCAMLR, so that the updated reference to the paper can be included in the *CCAMLR Scientific Abstracts* series.

PART II

SUBMISSION OF PAPERS TO MEETINGS OF THE WORKING GROUPS

Papers must be submitted by email to the Secretariat (webmaster@ccamlr.org) by no later than 0900 h on the Monday exactly two weeks prior to the commencement of the meeting, based on Eastern Australia standard time ('Hobart' time).

2. Papers should be brief and should target specific agenda items. Authors should note that long papers may not be given full attention if there is limited time. Each paper must include a one-page synopsis consisting of an abstract of the paper and a summary of the findings, as these relate to the nominated agenda items (see Appendix B).
3. Only papers accompanied by a completed one-page synopsis and submitted electronically by the deadline will be considered.
4. If a paper is intended for consideration for publication in *CCAMLR Science*, it should be accompanied by the document submission form provided in Appendix A. If a paper is received without this form, it will be assumed that the authors do not wish it to be considered for publication in *CCAMLR Science*.
5. When submitting a paper which has been published elsewhere, authors should give details of the paper's publication in the space provided on the synopsis.
6. The responsibility for any copyright issue related to the submission of published papers to working group meetings rests with the authors (SC-CAMLR-XXIII, paragraph 12.19). Papers that are 'in press' at the time of the meeting should be considered as published documents with respect to copyright.

7. For WG-FSA, papers containing results of stock assessment surveys or stock assessment analyses should include, as far as possible, all the types of information identified by WG-FSA (see SC-CAMLR-IX, Annex 5, Appendix F).

8. With the exception of Secretariat papers dealing with data², the deadline will apply to all documents submitted to WG-EMM, WG-FSA and WG-SAM, including SC-CAMLR and CCAMLR working papers and background papers (SC-CAMLR-XXIII, paragraph 12.15).

9. Papers submitted after the deadline and before the start of the meeting may be accepted, subject to prior notification, at the discretion of the Conveners of WG-EMM, WG-FSA, ad hoc WG-IMAF and WG-SAM, and the Chair of the Scientific Committee. This exemption applies only to those papers which would make a significant difference to the conduct of the meeting, or would impact on the decision of the Commission.

10. Factual corrections to papers will be accepted at any time. However, if such corrections are made after the deadline, then the author(s) must clearly indicate the changes in the revised paper(s). Papers with any other type of revision will be considered as new and will be subject to the deadline.
