Transfers from airport to hotel:

There is an Airport bus which stops at SAS Bryggen (adjacent to the Radisson), the Fishmarket and other places in the centre of Bergen. The Comfort Hotel Holberg and the Augustin Hotel are a 5-minute walk from the Fishmarket.

Visas:

Citizens from Schengen states and countries Norway has signed a visa waiver agreement with (see below) do not need a visa. More information is available from www.udi.no/templates/Tema.aspx?id=4477.

Host city information:

Information about Bergen can be found at www.visitbergen.com/default.asp?sp=GB. July is midsummer, but often rainy. The temperatures are changeable: 15–30°C, with an average of about 20°C.

Internet and IT:

Internet will be available. Participants will need to provide their own laptops for connecting to the meeting network. Electricity in Norway operates at 220 volts (50 Hz), with two-pin sockets. A two-pin continental adaptor is needed.

Money:

The currency is the Norwegian Kroner (NOK). The current exchange rate is US\$1 = 7 NOK. There are banks and ATMs located near the meeting venue and the hotels. There is also a bank and ATM at the Bergen Airport (Flesland).

Visa Information

Schengen countries

As part of the Schengen Agreement, there are no passport controls when travelling between countries which have signed up to the agreement. Citizens of these countries may therefore enter Norway freely, without having to apply for a visa. The same applies to foreign nationals who have a residence permit for one of the Schengen countries. The 25 member states are Austria, Belgium, the Czech Republic, Denmark, Estonia, Finland, France, Germany, Greece, Hungary, Iceland, Italy, Latvia, Lithuania, Luxembourg, Malta, the Netherlands, Norway, Poland, Slovakia, Slovenia, Portugal, Spain, Sweden and Switzerland.

It should be noted that European countries such as Ireland, Russia, Turkey and the United Kingdom are not parties to the agreement.

Countries exempt from visa requirement

A visa is not required for nationals of countries with which Norway has signed a visa waiver agreement. Nationals of countries with a visa waiver may stay in Norway for up to 90 days. The countries with which Norway has a visa waiver agreement are:

A: Andorra, Argentina, Australia, Austria
B: Belgium, Bermuda (BDTC passport), Brazil, Brunei, Bulgaria
C: Canada, Chile, Costa Rica, Croatia, Cyprus, Czech Republic
D: Denmark
E: El Salvador, Estonia
F: Finland, France
G: Germany, Greece, Guatemala
H: Hong Kong (SAR passport), Honduras, Hungary
I: Iceland, Ireland, Israel, Italy
J: Japan
K: Korean Republic
L: Latvia, Liechtenstein, Lithuania, Luxembourg
M: Macau (SAR passport), Malaysia, Malta, Mexico, Monaco
N: Netherlands, New Zealand, Nicaragua
P: Panama, Paraguay, Poland, Portugal
R: Romania
S: San Marino, Singapore, Slovakia, Slovenia, Spain, Sweden
U: UK, Uruguay, USA
V: Vatican State, Venezuela
