Notifications for New and Exploratory Fisheries in 2009/10

Members are advised that 11 Members have submitted notifications for new and exploratory fisheries in 2009/10.

The notifications are for exploratory longline fisheries for *Dissostichus* spp. in Subareas 48.6, 88.1 and 88.2 and Divisions 58.4.1, 58.4.2, 58.4.3a and 58.4.3b, for an exploratory trawl fishery for *Euphausia superba* in Subarea 48.6 and for exploratory pot fisheries for crab in Subareas 48.2 and 48.4 (summary attached). One Member (Argentina) has indicated that it intends to also use pots to catch *Dissostichus* spp. in Subareas 88.1 and 88.2 subject to approval by the Commission.

In addition to the information above, one Member (Russia) has notified its intention to fish for crabs in Subarea 48.3 in accordance with Conservation Measure 52-01, and to fish for *Dissostichus* spp. in Subarea 48.4 in accordance with Conservation Measure 41-03.

Notifications for New and Exploratory Fisheries will be placed, in their original language, on the 'Members Only' section of the CCAMLR website by 7 August 2009.

Members are reminded that the Secretariat should be notified as soon as payments are made. The CCAMLR website will be updated on 4 September 2009 and only paid notifications will be submitted to the Commission as CCAMLR-XXVIII documents.

In accordance with Conservation Measure 22-06, most Members have provided preliminary assessments of known and anticipated impacts of notified new and exploratory fishing activities on vulnerable marine ecosystems together with summary pages for translation. These assessment summaries will be translated and submitted to the Commission as a CCAMLR-XXVIII working document.
