Secretariat visit to the Republic of Korea

During CCAMLR-XXIX the Republic of Korea extended an invitation to the Secretariat to visit to Korea to provide a focused briefing on CCAMLR's requirements of Flag States whose fishing vessels operate in the Southern Ocean. Hosted by the Government of the Republic of Korea and the Korean Overseas Fisheries Association, the Secretariat's Science Officer, Dr Keith Reid, and Scientific Observer Data Analyst, Mr Eric Appleyard, visited Korea last week where they held focused meetings with government officials, scientists, representatives of the fishing industry, vessel captains, scientific observers and NGOs. The purpose of the meetings was to raise awareness and increase understanding of CCAMLR and the requirements of conservation measures that have been adopted by the Commission with a focus on krill and toothfish. In accordance with a request from Dr Sunpyo Kim, Head of the Korean Delegation to CCAMLR and Director of the International Legal Affairs Division, Ministry of Foreign Affairs and Trade in Korea, I am circulating the attached letter of appreciation.
