These notifications are for exploratory longline fisheries for Dissostichus spp. in Subareas 48.6, 88.1 and 88.2 and Divisions 58.4.1, 58.4.2, 58.4.3a and 58.4.3b (summary No notifications were received for new fisheries in 2010/11 (Conservation attached). Measure 21-01).

All notifying Members also provided preliminary assessments of known and anticipated impacts of exploratory fishing activities on vulnerable marine ecosystems (Conservation Measure 22-06).
