### **Introduction**

This Circular is intended to provide a brief update on various items of general interest to Members. It deviates from previous Circulars by presenting a number of issues in one Circular. The Secretariat would welcome feedback on the usefulness, content and format for periodic updates such as this.

### **Compliance Officer**

CCAMLR's Compliance Officer, Natasha Slicer, who expertly served CCAMLR for close to 14 years, has resigned from the Secretariat. I am sure all Members join me in wishing Natasha well with her future endeavours and thank her for her dedication and commitment to CCAMLR during her term with the organisation. Ms Sarah Reinhart has been recruited as CCAMLR's new Compliance Officer. Sarah joins the organisation with a strong background in fisheries law enforcement at the Australian national level. We all look forward to a long and productive association with Sarah.

### **Strategic Plan Review**

The Secretariat commenced an all-inclusive review of the 2002 Strategic Plan with a series of in-house workshops and thematic discussion groups in January and February involving all staff. In addition, 76 responses were received to the online Stakeholder Questionnaire. Thanks to all those who took the time to complete that Questionnaire. We plan to produce a new Draft Strategic Plan by mid-July.

### **Data Systems Management Review**

Following a competitive bidding process, Taz-e Ltd, an information technology company based in Hobart, was selected to undertake this Review for the Commission (refer to CCAMLR-XXIX, paragraph 3.7). The Review commenced in late January and is scheduled for completion in early April. Outcomes will, to the extent possible, be taken into account during the completion of the Strategic Plan review exercise.

## SC-CAMLR-XXIX Report

Further to COMM CIRC 11/13–SC CIRC 11/05, Members are advised that the pre-release English version of the SC-CAMLR-XXIX Report available on the ‘[Publications](#)’ public domain webpage now contains the Report of the 2010 meeting of WG-FSA.

Approval should be sought from the CCAMLR Secretariat prior to referencing material included in this pre-release version.
