

**Évaluation annuelle du respect des mesures de conservation**

Lors de la réunion CCAMLR-XXIII, la Commission a approuvé les objectifs de l'évaluation annuelle du respect de la réglementation, ainsi que les démarches identifiées par le SCIC en vue de sa préparation (CCAMLR-XXIII, paragraphe 6.7; CCAMLR-XXIII, annexe 5, paragraphes 3.27 à 3.30). La Commission a chargé le secrétariat d'identifier les types de données de contrôle utilisées actuellement dans l'évaluation du respect des mesures de conservation et les méthodes de collecte de ces données. La Commission a également convenu que le SCIC et le Comité scientifique devraient apporter des commentaires sur ces méthodes et présenter des recommandations sur leur modification ou leur adoption par la réunion de la Commission en 2005 (CCAMLR-XXIII, paragraphe 6.11; CCAMLR-XXIII, annexe 5, paragraphe 3.30).

Le secrétariat a préparé un tableau récapitulatif des informations demandées par la Commission (ci-joint) qu'il envoie aux membres de la Commission, du SCIC et du Comité scientifique pour considération et commentaires. Les commentaires reçus avant le 1<sup>er</sup> septembre 2005 seront insérés dans le tableau révisé qui sera soumis à CCAMLR-XXIV.

Lors de la préparation du tableau susmentionné, le secrétariat a tenu compte du fait que l'évaluation annuelle proposée du respect des mesures de conservation et de leur performance contient des dispositions susceptibles de nécessiter une clarification, notamment à l'égard des critères d'évaluation et de la division des responsabilités entre le SCIC et le Comité scientifique.
