Members are advised that 10 Members have submitted notifications for exploratory fisheries in 2010/11 (Conservation Measure 21-02).

These notifications are for exploratory longline fisheries for *Dissostichus* spp. in Subareas 48.6, 88.1 and 88.2 and Divisions 58.4.1, 58.4.2, 58.4.3a and 58.4.3b (summary attached). No notifications were received for new fisheries in 2010/11 (Conservation Measure 21-01).

All notifying Members also provided preliminary assessments of known and anticipated impacts of exploratory fishing activities on vulnerable marine ecosystems (Conservation Measure 22-06).

Notifications for 2010/11 and the preliminary assessments will be placed, in their original language, on the 'Members Only' section of the CCAMLR website by 6 August 2010.
