On the delay of fishing vessel «CALIPSO»

The State Agency of Fisheries of Ukraine would like to express the assurances of its highest respect to the Commission for the Conservation of Antarctic Marine Living Resources and has the honor to inform you about the following.

The owner of the fishing vessel «CALIPSO» flying the flag of Ukraine harvesting toothfish in the CCAMLR Convention Area informed the State Agency of Fisheries of Ukraine about the delay in the removal of fishing gears due to the difficult weather conditions after the closure of CCAMLR Subarea 88.2_2.

The vessel placed the long-line number 73 with 19320 hooks on January 27, 2021, from 17:18 till 18:53 (UTC), between the coordinates $-73^{\circ}52.54'S, -118^{\circ}38'W$ and $-73^{\circ}59.85'S, 118^{\circ}20.01'W$.

As soon as this notification from the CCAMLR Secretariat about the planned closure of fishing activity in Subarea 88.2_2 was received, the fishing vessel «CALIPSO» did not place any new fishing gears and sent a notice to the CCAMLR Secretariat about possible delay.

The vessel completed lifting the long-line number 73 on January 30, 2021 at 17:04 (UTC) and went beyond Subarea 88.2_2.

Taking this into account, please note the above information and bring it to the attention of the Member States of the CCAMLR.

The State Agency of Fisheries of Ukraine takes this opportunity to renew the assurance of its highest consideration to the Commission for the Conservation of Antarctic Marine Living Resources and hopes to continue fruitful cooperation.
